**A BILL FOR AN ACT**

101 **CONCERNING SUPPLEMENTAL FUNDING FOR FACILITY SCHOOLS, AND,**  
102 **IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

---

**Bill Summary**

*(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. **Joint Budget Committee.** The bill requires, in state fiscal year 2022-23 only, and within available appropriations, that the department of education (department) distribute supplemental payments to facility schools approved by the department as of October 1, 2022. The supplemental payments must be above and beyond the current daily per pupil revenue rate as established for the 2022-23 state fiscal year.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 22-2-408, **add** (4) as  
3 follows:

4           **22-2-408. Approved facility schools - funding.** (4) IN STATE  
5 FISCAL YEAR 2022-23 ONLY, AND WITHIN AVAILABLE APPROPRIATIONS,  
6 THE DEPARTMENT SHALL DISTRIBUTE SUPPLEMENTAL PAYMENTS TO  
7 APPROVED FACILITY SCHOOLS THAT ARE APPROVED BY THE DEPARTMENT  
8 AS OF OCTOBER 1, 2022. THE SUPPLEMENTAL PAYMENTS MUST BE ABOVE  
9 AND BEYOND THE CURRENT DAILY PER PUPIL REVENUE RATE AS  
10 ESTABLISHED FOR THE 2022-23 STATE FISCAL YEAR. THE DEPARTMENT  
11 SHALL DETERMINE THE METHOD THROUGH WHICH THE SUPPLEMENTAL  
12 PAYMENTS ARE DISTRIBUTED TO ALL APPROVED FACILITY SCHOOLS AND  
13 SHALL ENSURE THAT THE SUPPLEMENTAL PAYMENTS MADE PURSUANT TO  
14 THIS SUBSECTION (4) ARE PAID TO THE APPROVED FACILITY SCHOOLS PRIOR  
15 TO JUNE 30, 2023.

16           **SECTION 2. Appropriation.** For the 2022-23 state fiscal year,  
17 \$5,134,000 is appropriated to the department of education. This  
18 appropriation is from the state education fund, created in section 17 (4)(a)  
19 of article IX of the state constitution. To implement this act, the  
20 department may use this appropriation for supplemental payments to  
21 facility schools.

22           **SECTION 3. Act subject to petition - effective date.** This act  
23 takes effect at 12:01 a.m. on the day following the expiration of the  
24 ninety-day period after final adjournment of the general assembly; except  
25 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
26 of the state constitution against this act or an item, section, or part of this

1 act within such period, then the act, item, section, or part will not take  
2 effect unless approved by the people at the general election to be held in  
3 November 2022 and, in such case, will take effect on the date of the  
4 official declaration of the vote thereon by the governor.
