A BILL FOR AN ACT

101 CONCERNING THE COMPENSATION OF TEACHERS EMPLOYED BY THE
102 COLORADO SCHOOL FOR THE DEAF AND THE BLIND.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill provides that, for any budget year, a teacher employed by the Colorado school for the deaf and the blind shall not receive an increase in compensation unless the general assembly appropriates such an increase to the department of education, school for the deaf and the blind, in the general appropriations act.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** 22-80-106.5 (3), Colorado Revised Statutes, is
3 amended to read:

4 **22-80-106.5. Compensation of teachers.** (3) Notwithstanding
5 the provisions of subsection (1) of this section:

6 (a) Any teacher who, when compensated in accordance with the
7 provisions of the salary schedule, salary policy, or combination salary
8 schedule and salary policy, would receive less compensation than he or
9 she received from the Colorado school for the deaf and the blind in the
10 budget year 1995-96 shall continue receiving the amount he or she
11 received in the budget year 1995-96 until compensation of that teacher in
12 accordance with the provisions of the salary schedule, salary policy, or
13 combination salary schedule and salary policy would result in an increase
14 in compensation over the amount received in the budget year 1995-96.

15 (b) FOR ANY BUDGET YEAR, A TEACHER EMPLOYED BY THE SCHOOL
16 MAY NOT RECEIVE ANY INCREASE IN COMPENSATION UNLESS THE GENERAL
17 ASSEMBLY APPROPRIATES THE AMOUNT REQUIRED FOR SUCH AN INCREASE
18 TO THE DEPARTMENT OF EDUCATION, SCHOOL FOR THE DEAF AND THE
19 BLIND, IN THE ANNUAL GENERAL APPROPRIATIONS ACT ENACTED FOR THE
20 APPLICABLE BUDGET YEAR.

21 **SECTION 2. Safety clause.** The general assembly hereby finds,
22 determines, and declares that this act is necessary for the immediate
23 preservation of the public peace, health, and safety.
