#### A BILL FOR AN ACT

## 101 CONCERNING CAPITAL-RELATED TRANSFERS OF MONEY.

### **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. **Joint Budget Committee.** For the 2019-20 state fiscal year, the bill transfers:

- ! \$1,397,624 from the general fund to the capital construction fund; and
- ! \$21,134,709 from the information technology capital account of the capital construction fund to the general fund. For the 2020-21 state fiscal year, the bill transfers:
- \$500,000 from the general fund exempt account of the

2 **SECTION 1.** In Colorado Revised Statutes, 24-75-302, amend 3 (2)(hh), (2.3) introductory portion, (2.3)(f), (2.3)(g), (2.5)(m), and 4 (2.5)(n); and add (2)(ij), (2)(kk), (2.3)(h), (2.5)(o), and (12) as follows: 5 24-75-302. Capital construction fund - capital assessment fees 6 - calculation - information technology capital account. (2) The 7 controller shall transfer a sum as specified in this subsection (2) from the 8 general fund to the capital construction fund as money becomes available 9 in the general fund during the fiscal year beginning on July 1 of the fiscal 10 year in which the transfer is made. Transfers between funds pursuant to 11 this subsection (2) are not appropriations subject to the limitations of 12 section 24-75-201.1. The amounts transferred pursuant to this subsection 13 (2) are as follows: 14 (hh) For the 2019-20 fiscal year, one hundred seventy-eight 15 thousand four hundred seventy-one dollars pursuant to H.B. 19-1250,

  (2) and (2.5) of this section, the state treasurer and the controller shall

Transfers between funds 6 pursuant to this subsection (2.3) are not appropriations subject to the 7 limitations of section 24-75-201.1. The amounts transferred pursuant to 8 this subsection (2.3) are as follows: 9 (f) On July 1, 2018, fifteen million two hundred six thousand 10 seven hundred sixty dollars; and 11 (g) On July 1, 2019, twelve million three hundred forty-two 12 thousand six hundred seventy-six dollars; AND 13 (h) On July 1, 2020, four hundred forty-five thousand 14 DOLLARS. 15 (2.5) In addition to the sums transferred pursuant to subsections 16 (2) and (2.3) of this section, the state treasurer and the controller shall 17 transfer a sum as specified in this subsection (2.5) from the general fund 18 exempt account of the general fund created pursuant to section 19 24-77-103.6 to the capital construction fund as money becomes available 20 in the general fund exempt account during the fiscal year beginning on 21 July 1 of the fiscal year in which the transfer is made. Transfers between 22 funds pursuant to this subsection (2.5) are not appropriations subject to 23 the limitations of section 24-75-201.1. The amounts transferred pursuant 24 to this subsection (2.5) are as follows: 25 (m) On July 1, 2018, five hundred thousand dollars; and 26 (n) On July 1, 2019, five hundred thousand dollars; AND

(o) On July 1, 2020, five hundred thousand dollars.
