A BILL FOR AN ACT

101 **CONCERNING AN EXCEPTION FROM THE MANDATORY REPORTING**
102 **REQUIREMENTS FOR PERSONS PROVIDING LEGAL ASSISTANCE TO**
103 **AREA AGENCIES ON AGING.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Under current law, staff, and staff of contracted providers, of area agencies on aging are mandatory reporters of the mistreatment of an at-risk elder or an at-risk adult with an intellectual and developmental disability. The bill creates a mandatory reporter exception for providers of legal assistance and their staff.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 18-6.5-108, **amend**
3 (1)(b)(XVII) as follows:

4 **18-6.5-108. Mandatory reports of mistreatment of at-risk**
5 **elders and at-risk adults with IDD - list of reporters - penalties.**

6 (1) (b) The following persons, whether paid or unpaid, shall report as
7 required by subsection (1)(a) of this section:

8 (XVII) Staff, and staff of contracted providers, of area agencies
9 on aging, except ATTORNEYS AT LAW PROVIDING LEGAL ASSISTANCE TO
10 INDIVIDUALS PURSUANT TO A CONTRACT WITH AN AREA AGENCY ON
11 AGING, THE STAFF OF SUCH ATTORNEYS AT LAW, AND the long-term care
12 ombudsmen;

13 **SECTION 2. Act subject to petition - effective date.** This act
14 takes effect September 1, 2018; except that, if a referendum petition is
15 filed pursuant to section 1 (3) of article V of the state constitution against
16 this act or an item, section, or part of this act within the ninety-day period
17 after final adjournment of the general assembly, then the act, item,
18 section, or part will not take effect unless approved by the people at the
19 general election to be held in November 2018 and, in such case, will take
20 effect on the date of the official declaration of the vote thereon by the
21 governor.
