A BILL FOR AN ACT

101 **CONCERNING THE INVOLUNTARY RELOCATION OF CORNHUSKER FANS**
102 **TO BUFFALO, NEW YORK.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <http://www.leg.state.co.us/billsummaries>.)

Currently, University of Nebraska Cornhusker fans (bad people) are permitted to live in the state of Colorado. **Sections 1 and 2** of the bill create a new division of populace improvement (new division) under the department of local affairs. **Section 2** further authorizes the new division to detect bad people and deport them from Colorado to Detroit, Michigan.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-1-125 (2), **add** (n)
3 as follows:

4 **24-1-125. Department of local affairs - creation.** (2) The
5 department of local affairs shall consist of the following divisions:

6 (m) THE DIVISION OF POPULACE IMPROVEMENT CREATED IN PART
7 99 OF ARTICLE 32 OF THIS TITLE.

8 **SECTION 2.** In Colorado Revised Statutes, **add** part 99 of article
9 32 of title 24 as follows:

10 **PART 99**

11 **POPULACE IMPROVEMENT**

12 **24-32-9901. Definitions.** AS USED IN THIS PART 99, UNLESS THE
13 CONTEXT OTHERWISE REQUIRES:

14 (1) "BAD PEOPLE" MEANS THOSE PERSONS SELF-IDENTIFYING AS
15 FANS OF THE UNIVERSITY OF NEBRASKA CORNHUSKERS. THE TERM
16 INCLUDES MATTHEW DAWKINS AND OTHER ALUMNI OF THAT SCHOOL.

17 (2) "DIVISION" MEANS THE DIVISION OF POPULACE IMPROVEMENT
18 CREATED IN SECTION 24-32-9902.

19 **24-32-9902. Division of populace improvement- creation.**
20 THERE IS HEREBY CREATED THE DIVISION OF POPULACE IMPROVEMENT,
21 THE HEAD OF WHICH IS RALPHIE THE BUFFALO.

22 **24-32-9903. Duties and powers - rules.** (1) BEGINNING JULY 1,
23 2014, BAD PEOPLE ARE PROHIBITED FROM RESIDING IN COLORADO.

24 (2) (a) PRIOR TO JULY 1, 2014, AND ON AN ONGOING BASIS
25 THEREAFTER, THE DIVISION SHALL DETERMINE THE NAMES AND
26 ADDRESSES OF BAD PEOPLE LIVING IN COLORADO.

1 (b) (I) ON AND AFTER JULY 1, 2014, THE DIVISION SHALL FORCIBLY
2 REMOVE BAD PEOPLE AND DEPORT THEM TO BUFFALO, NEW YORK.

3 (II) BAD PEOPLE BEING DEPORTED ARE PERMITTED TO BRING ALL
4 CORNHUSKER-RELATED PARAPHERNALIA WITH THEM. ANY SUCH ITEMS
5 LEFT IN COLORADO MUST BE DESTROYED VIA BONFIRE DURING THE
6 UNIVERSITY OF COLORADO'S HOMECOMING FOOTBALL GAME.

7 (3) RALPHIE THE BUFFALO MAY PROMULGATE ANY ARBITRARY
8 AND CAPRICIOUS RULES, INCLUDING THOSE DEEMED UNREASONABLE AND
9 UNNECESSARY, TO IMPLEMENT THE REQUIREMENTS OF THIS SECTION.

10 **SECTION 3. Safety clause.** The general assembly hereby finds,
11 determines, and declares that this act is necessary for the immediate
12 preservation of the public peace, health, and safety.
