The concurrent resolution incrementally increases the statewide



minimum wage from the current amount of \$8.23 to \$12.50 from January 1, 2017, to January 1, 2020, as follows:

1	Be It Resolved by the House of Representatives of the Seventieth
2	General Assembly of the State of Colorado, the Senate concurring herein:
3	SECTION 1. At the election held on November 8, 2016, the
4	secretary of state shall submit to the registered electors of the state the
5	ballot title set forth in section 2 for the following amendment to the state
6	constitution:
7	In the constitution of the state of Colorado, amend section 15 of
8	article XVIII as follows:
9	Section 15. State minimum wage rate. (1) (a) Effective
10	January 1, 2007 2017, Colorado's minimum wage shall be increased to
11	\$6.85 \$9.50 per hour. and
12	(b) EFFECTIVE JANUARY 1, 2018, COLORADO'S MINIMUM WAGE
13	SHALL BE INCREASED TO $$10.50$ per hour.
14	(c) EFFECTIVE JANUARY 1, 2019, COLORADO'S MINIMUM WAGE
15	SHALL BE INCREASED TO $$11.50$ per hour.
16	(d) EFFECTIVE JANUARY 1, 2020, COLORADO'S MINIMUM WAGE
17	SHALL BE INCREASED TO $$12.50$ per hour.
18	(2) EFFECTIVE JANUARY 1, 2021, THE MINIMUM WAGE shall be
19	adjusted INCREASED annually for inflation, as measured by the Consumer
20	Price Index used for Colorado.
21	(3) This The minimum wage IN SUBSECTION (1) OF THIS SECTION
22	shall be paid to employees who receive the state or federal minimum

1 wage.

2 (4) No more than \$3.02 per hour in tip income may be used to
3 offset the minimum wage of employees who regularly receive tips.

4 SECTION 2. Each elector voting at the election may cast a vote 5 either "Yes/For" or "No/Against" on the following ballot title: "Shall 6 there be an amendment to the Colorado constitution concerning an 7 increase in the statewide minimum wage, and, in connection therewith, 8 raising the minimum wage to \$9.50 on January 1, 2017, \$10.50 on 9 January 1, 2018, \$11.50 on January 1, 2019, and \$12.50 on January 1, 10 2020?".

SECTION 3. Except as otherwise provided in section 1-40-123,
Colorado Revised Statutes, if a majority of the electors voting on the
ballot title vote "Yes/For", then the amendment will become part of the
state constitution.
