1 *Be It Resolved by the House of Representatives of the Seventy-third*
2 *General Assembly of the State of Colorado, the Senate concurring herein:*

3 **SECTION 1.** At the election held on November 8, 2022, the
4 secretary of state shall submit to the registered electors of the state the
5 ballot title set forth in section 2 for the following amendment to the state
6 constitution:

7 In the constitution of the state of Colorado, **repeal** section 23 of
8 article IV as follows:

9 **Section 23. Commissioner of insurance.** ~~The governor shall~~
10 ~~nominate and, by and with the consent of the senate, appoint the~~
11 ~~commissioner of insurance to serve at his pleasure, and the state~~
12 ~~personnel system shall not extend to the commissioner of insurance.~~

13 **SECTION 2.** Each elector voting at the election may cast a vote
14 either "Yes/For" or "No/Against" on the following ballot title: "Shall
15 there be an amendment to the Colorado constitution concerning the repeal
16 of the requirement that the insurance commissioner be appointed by the
17 governor with the consent of the senate?"

18 **SECTION 3.** Except as otherwise provided in section 1-40-123,
19 Colorado Revised Statutes, if a majority of the electors voting on the
20 ballot title vote "Yes/For", then the amendment will become part of the
21 state constitution.
