1 WHEREAS, Thousands of military personnel from Colorado have 2 served around the world in the ongoing war against terrorism, including 3 troops based at Fort Carson, the United States Air Force Academy, 4 Peterson Air Force Base, and Buckley Air Force Base; members of the 5 Colorado National Guard, Army Reserve, and Marine Corps Reserve; and 6 troops from Colorado who are deployed with military units based in other 7 states; and
