Oswell's military decorations include the Bronze Star, the Air Medal (2 awards), the Army Commendation Medals (3 awards) with "V" device for Valor, the Army Achievement Medal (2 awards), the Navy Achievement Medal, the Army Good Conduct Medal, the Marine Corps Good Conduct Medal (2 awards), the Iraq Campaign Medal, the Global War on Terrorism Expeditionary Medal, and the Global War on Terrorism Service Medal, and CW3 Scott A. M. Oswell was inducted into the prestigious Sergeant Audie Murphy Club; and
