

HOUSE RESOLUTION 14-1001

CONCERNING CHANGES TO THE HOUSE RULES REGARDING THIRD READING AMENDMENTS.

Be It Resolved by the House of Representatives of the Sixty-ninth General Assembly of the State of Colorado:

That in the Rules of the House of Representatives, Rule No. 33, amend (b); and add (b.5) as follows:

33. Third Reading and Final Passage of Bills

- (b) No amendment to a bill on third reading shall be IS in order except with the consent of a majority of all members elected. A SUBSTITUTE AMENDMENT TO A THIRD READING AMENDMENT IS NEVER IN ORDER.
- (b.5) EXCEPT DURING THE LAST THREE DAYS OF A LEGISLATIVE SESSION, ONLY AN AMENDMENT TO A BILL ON THIRD READING THAT IS NOT SUBSTANTIAL IS IN ORDER. UPON CONSENT OF A MAJORITY OF ALL MEMBERS ELECTED, A BILL MAY BE REFERRED BACK TO SECOND READING FROM THIRD READING FOR CONSIDERATION OF A SUBSTANTIAL AMENDMENT TO THE BILL.

That in the Rules of the House of Representatives, Rule No. 7, **add** (c) (9.5) as follows:

7. Motions

- (c) When a question shall be under debate, the Speaker shall entertain no motion except:
 - (9.5) TO REFER A BILL BACK TO SECOND READING FROM THIRD READING FOR THE PURPOSE OF CONSIDERATION OF A SUBSTANTIAL AMENDMENT TO THE BILL.

That in the Rules of the House of Representatives, Rule No. 9, **amend** (a); and **add** (a.5) as follows:

9. Motion to Refer

Motions to refer shall take precedence in the following order:

- (a) To a committee of reference of the House SECOND READING FROM THIRD READING FOR THE PURPOSE OF CONSIDERATION OF A SUBSTANTIAL AMENDMENT TO THE BILL.
- (a.5) TO A COMMITTEE OF REFERENCE OF THE HOUSE.

That in the Rules of the House of Representatives, Rule No. 29, **add** (k) (4.5) as follows:

29. Course of Bills

The course of every bill in its introduction, reference, consideration, and passage through the House shall be as follows:

(k) Consideration of the bill by the House on third reading and final passage, during which the following motions shall be in order:

TO SECOND READING FOR THE PURPOSE OF CONSIDERATION OF A SUBSTANTIAL AMENDMENT TO THE BILL.

(4.5) That the bill be referred from third reading back
