**A BILL FOR AN ACT**

101      **CONCERNING EXTENDING THE DEADLINE FOR PEACE OFFICERS TO**  
102      **COMPLETE DOG ENCOUNTER TRAINING TO JUNE 30, 2015.**

**Bill Summary**

Currently, law enforcement officers are required to complete dog encounter training by January 1, 2015, and any officer hired on or after January 1, 2015, must complete the training within a year of being hired. The bill moves the deadline to June 30, 2015.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** The general assembly  
3 hereby finds and declares that in enacting Senate Bill 15-013, it is  
4 strengthening the provisions of the "Dog Protection Act". It is not the  
5 general assembly's intent to diminish the original substantive portions of  
6 the "Dog Protection Act".

7 **SECTION 2.** In Colorado Revised Statutes, 29-5-112, **amend** (2)  
8 introductory portion, (4) (a) (II) (B), and (4) (a) (II) (C); and **add** (2) (c)  
9 as follows:

10 **29-5-112. Dog interactions with local law enforcement officers**  
11 **- training to be provided by local law enforcement agencies - policies**  
12 **and procedures - scope - task force - creation - composition -**  
13 **immunity - definitions - short title - legislative declaration - repeal.**

14 (2) **Legislative declaration.** The general assembly finds, determines, and  
15 declares that it is the policy of this state to prevent, whenever possible,  
16 the shooting of dogs by local law enforcement officers in the course of  
17 performing their official duties. It is therefore the intent of the general  
18 assembly ~~in adopting this section~~ to:

19 (c) RECOGNIZE THE IMPORTANT WORK OF THE DOG PROTECTION  
20 TASK FORCE IN DEVELOPING THE TRAINING AND INCORPORATING THE  
21 SPECIFICS OF THE TRAINING INTO THE STATUTES. THE SEVENTEEN  
22 MEMBERS APPOINTED TO THE TASK FORCE REPRESENTED A VICTIM OF A  
23 DOG SHOOTING, VETERINARIANS, ANIMAL WELFARE ADVOCATES, ANIMAL  
24 BEHAVIORISTS, ANIMAL CONTROL OFFICERS, THE SHERIFFS, THE POLICE,  
25 AND LEGAL PROFESSIONALS. THE TRAINING INCLUDES INSTRUCTION  
26 REGARDING A DOG'S BODY LANGUAGE AND HOW TO INTERPRET IT, SCENE  
27 ASSESSMENT, TOOLS TO USE IN DOG ENCOUNTERS, SITUATIONS INVOLVING

1 MULTIPLE DOGS, HOW TO INTERACT WITH A DOG, AND RESPONSES TO DOG  
2 BEHAVIOR. THE DOG ENCOUNTERS TRAINING REQUIRED BY THIS SECTION  
3 WAS DESIGNED TO PROTECT LAW ENFORCEMENT OFFICERS, ANIMAL  
4 CONTROL OFFICERS, DOG OWNERS, INNOCENT BYSTANDERS, AND THE DOG.  
5 THE TRAINING IS NOT INTENDED TO PROVIDE DANGEROUS DOG TRAINING.  
6 MOST IMPORTANTLY, THE TRAINING WAS DESIGNED TO LIMIT, AS MUCH AS  
7 FEASIBLE, THE INSTANCES IN WHICH AN OFFICER WOULD NEED TO USE  
8 DEADLY FORCE AGAINST A DOG, SINCE THE POSSIBILITY OF COLLATERAL  
9 DAMAGE, INJURY, OR DEATH FROM STRAY ROUNDS IS EVER-PRESENT WHEN  
10 A LAW ENFORCEMENT OFFICER USES DEADLY FORCE.

11 (4) **Training required.** (a) (II) Each local law enforcement  
12 agency in the state shall:

13 (B) Require its current local law enforcement officers to complete  
14 the training program required by this subsection (4) by ~~January 1,~~ JUNE  
15 30, 2015; and

16 (C) Require all local law enforcement officers hired on or after  
17 ~~January 1,~~ JUNE 30, 2015, to complete the training required by this  
18 subsection (4) within each officer's first year of employment.

19 **SECTION 3. Safety clause.** The general assembly hereby finds,  
20 determines, and declares that this act is necessary for the immediate  
21 preservation of the public peace, health, and safety.
