101	CONCERNING THE CREATION OF A RURAL ECONOMIC EMERGENCY
102	ASSISTANCE GRANT PROGRAM FOR THE PROVISION OF

Bill Summary

The bill creates:

- The rural economic emergency assistance grant program (program) in the division of local government within the department of local affairs (division) for the purpose of disbursing emergency-based grant funds to rural communities experiencing significant economic events, such as a plant closure or layoffs including industry-wide layoffs, that have a significant, quantifiable impact on the unemployment rate within the rural community; and
- ! The rural economic emergency assistance grant fund, to be administered by the director of the division for implementation of the program and into which \$2 million is transferred from the general fund for the 2015-16 fiscal year and to which gifts, grants, and donations may be transmitted.

6	(c) THE DIRECTOR MAY ACCEPT AND EXPEND GIFTS, GRANTS, AND

13	SECTION 3. Safety clause. The general assembly hereby finds,
14	determines, and declares that this act is necessary for the immediate
15	preservation of the public peace, health, and safety.
