A BILL FOR AN ACT

101 **CONCERNING THE COMPLETION OF THE CEMETERY EXPANSION**
102 **PROJECT AT THE HOMELAKE MILITARY VETERANS CEMETERY,**
103 **AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill clarifies that the cemetery at the Colorado state veterans center at Homelake military veterans cemetery includes the 2 triangular areas that are adjacent to, and to the northeast and northwest of, the circular cemetery proper.

The bill directs the state department of human services (state department) to complete by July 1, 2013, the ongoing project to expand the existing cemetery and make available new cemetery plots for eligible veterans of the United States armed forces and their spouses.

The bill directs the state department to submit on or before January 1, 2014, to the state, military, and veterans affairs committees of the house of representatives and senate a report concerning:

- ! The completion of the project to expand the existing cemetery;
- ! The day-to-day and yearly requirements that are involved in the maintenance of the cemetery;
- ! The extent to which the state department relies upon state employees for the actual maintenance of the cemetery; and
- ! The extent to which the state department contracts with other public or private entities for the actual maintenance of the cemetery.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 26-12-205, **amend**
3 (1) (a) and (4) (b); and **add** (8) as follows:

4 **26-12-205. Homelake military veterans cemetery - definitions**
5 **- fund - rules - notice of funding through gifts, grants, and donations**
6 **- repeal.** (1) As used in this section, unless the context otherwise
7 requires:

8 (a) "Cemetery" means the Homelake military veterans cemetery
9 established and maintained at the center pursuant to subsection (2) of this
10 section, including:

11 (I) THE TWO TRIANGULAR AREAS THAT ARE ADJACENT TO, AND TO
12 THE NORTHEAST AND NORTHWEST OF, THE CIRCULAR CEMETERY PROPER;
13 AND

14 (II) The triangular area of land to the direct north of the existing
15 cemetery as of May 3, 2012.

16 (4) (b) (I) The state department is authorized to accept gifts,

1 grants, and donations for the purposes of this section; except that the state
2 department shall not accept a gift, grant, or donation that is subject to
3 conditions that are inconsistent with the provisions of this section or any
4 other law of the state. The state department shall transfer all private and
5 public moneys received through gifts, grants, and donations to the state
6 treasurer, who shall credit the same to the fund.

7 (II) TO THE EXTENT PERMITTED BY SUBPARAGRAPH (I) OF THIS
8 PARAGRAPH (b), A PERSON WHO CONTRIBUTES A GIFT, GRANT, OR
9 DONATION TO THE FUND MAY DESIGNATE A SPECIFIC PURPOSE FOR WHICH
10 THE GIFT, GRANT, OR DONATION IS TO BE USED. THE STATE DEPARTMENT
11 SHALL NOT UNREASONABLY DELAY A PROJECT THAT IS SUFFICIENTLY
12 FUNDED BY GIFTS, GRANTS, OR DONATIONS.

13 (8) (a) ON OR BEFORE JANUARY 1, 2014, THE STATE DEPARTMENT
14 SHALL ESTABLISH A PHASED PLAN FOR EXPANSION OF THE CEMETERY. THE
15 STATE DEPARTMENT SHALL IDENTIFY PHASES IN A MANNER THAT IS
16 AESTHETICALLY APPROPRIATE, COST-EFFECTIVE, AND CAPABLE OF
17 INCREMENTAL IMPLEMENTATION AS FUNDING BECOMES AVAILABLE;
18 EXCEPT THAT, THE FIRST PHASE SHALL CONSIST OF THE PORTION OF THE
19 PROJECT DESCRIBED IN PARAGRAPH (b) OF THIS SUBSECTION (8). THE
20 EXPANSION PROJECT SHALL INCLUDE WORK SUFFICIENT TO MEET THE
21 DEMAND FOR UNRESERVED BURIAL PLOTS IN THE CEMETERY AND TO
22 ALLOW THE STATE DEPARTMENT TO CONDUCT INTERMENTS AT THE RATE
23 OF FIFTEEN INTERMENTS PER YEAR. TO THE EXTENT PRACTICABLE, IN
24 IMPLEMENTING THE EXPANSION PLAN, THE STATE DEPARTMENT SHALL
25 MAKE USE OF WORK COMPLETED BY THIRD PARTIES PURSUANT TO
26 PARAGRAPH (b) OF SUBSECTION (2) OF THIS SECTION AND COORDINATE
27 WITH SUCH PARTIES TO ENSURE THAT WORK COMPLETED FOR THE

1 EXPANSION PROJECT MEETS THE STANDARDS AND SPECIFICATIONS OF THE
2 PHASED PLAN.

3 (b) ON OR BEFORE JULY 1, 2014, THE STATE DEPARTMENT SHALL
4 COMPLETE THE EXPANSION OF THE CEMETERY AND MAKE AVAILABLE FOR
5 ELIGIBLE VETERANS OF THE UNITED STATES ARMED FORCES AND THEIR
6 SPOUSES NEW CEMETERY PLOTS IN THE TWO TRIANGULAR AREAS THAT ARE
7 ADJACENT TO, AND TO THE NORTHEAST AND NORTHWEST OF, THE
8 CIRCULAR CEMETERY PROPER.

9 (c) (I) ON OR BEFORE JANUARY 1, 2015, THE STATE DEPARTMENT
10 SHALL SUBMIT TO THE STATE, MILITARY, AND VETERANS AFFAIRS
11 COMMITTEES OF THE HOUSE OF REPRESENTATIVES AND SENATE, OR ANY
12 SUCCESSOR COMMITTEE, A REPORT CONCERNING:

13 (A) THE STATUS OF THE PHASED PLAN FOR EXPANSION OF THE
14 CEMETERY;

15 (B) THE DAY-TO-DAY AND YEARLY REQUIREMENTS THAT ARE
16 INVOLVED IN THE MAINTENANCE OF THE CEMETERY;

17 (C) THE EXTENT TO WHICH THE DEPARTMENT RELIES UPON STATE
18 EMPLOYEES FOR THE ACTUAL MAINTENANCE OF THE CEMETERY; AND

19 (D) THE EXTENT TO WHICH THE STATE DEPARTMENT CONTRACTS
20 WITH OTHER PUBLIC OR PRIVATE ENTITIES, AS DESCRIBED IN PARAGRAPH
21 (b) OF SUBSECTION (2) AND SUBSECTION (6) OF THIS SECTION, FOR THE
22 ACTUAL MAINTENANCE OF THE CEMETERY.

23 (II) THIS PARAGRAPH (c) IS REPEALED, EFFECTIVE JANUARY 2,
24 2015.

25 SECTION 2. Appropriation. In addition to any other
26 appropriation, there is hereby appropriated, out of any moneys in the
27 general fund not otherwise appropriated, to the department of human

1 services, for the fiscal year beginning July 1, 2013, the sum of \$99,575,
2 or so much thereof as may be necessary, for allocation to the homelake
3 military veterans cemetery line item for construction costs related to the
4 implementation of this act.

5 **SECTION 3. Safety clause.** The general assembly hereby finds,
6 determines, and declares that this act is necessary for the immediate
7 preservation of the public peace, health, and safety.
