101     **CONCERNING THE RENEWAL OF DISTINGUISHED FOREIGN TEACHING**  
102             **PHYSICIAN LICENSES BY A PERSON RANKED LOWER THAN AN**

**Bill Summary**

Current law allows distinguished foreign teaching physicians to be licensed to practice medicine at a state medical school. The license is valid for one year only; to renew the license, the distinguished foreign teaching physician must have been invited by the school to serve as a

full-time member of its academic faculty at a rank equal to an associate professor or higher. Assistant professors cannot renew their licenses.

The bill allows an assistant professor who is a distinguished foreign teaching physician to renew his or her license.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-36-107.2, **amend**  
3 (3) as follows:

4 **12-36-107.2. Distinguished foreign teaching physician license**  
5 **- qualifications.** (3) A distinguished foreign teaching physician license  
6 is effective and in force only while the holder is serving on the academic  
7 staff of a medical school. The license expires one year after the date of  
8 issuance and may be renewed annually only after the board has  
9 specifically determined that the conditions specified in subsection (1) OR  
10 (2) of this section will continue during the ensuing period of licensure.  
11 The board may require an applicant for licensure under this section to  
12 present himself or herself to the board for an interview. The board may  
13 withdraw licensure granted under this section prior to the expiration of  
14 the license for unprofessional conduct as defined in section 12-36-117.

15 **SECTION 2. Applicability.** This act applies to license renewal  
16 applications filed on or after the effective date of this act.

17 **SECTION 3. Safety clause.** The general assembly hereby finds,  
18 determines, and declares that this act is necessary for the immediate  
19 preservation of the public peace, health, and safety.
