1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 32-9-119.7, **amend**
3 (2) as follows:

4 **32-9-119.7. Cost efficiency of transit services - reporting -**
5 **plans - definition.** (2) For the purposes of this section, "operating costs"
6 means all OPERATING expenditures, ~~including~~ EXCLUDING depreciation.
7 ~~except for those incurred in long-term planning and development of mass~~
8 ~~transportation and rapid transit infrastructures and those costs incurred as~~
9 ~~a result of providing transportation service mandated by the federal~~

12 **SECTION 2. Act subject to petition - effective date.** This act
13 takes effect at 12:01 a.m. on the day following the expiration of the
14 ninety-day period after final adjournment of the general assembly; except
15 that, if a referendum petition is filed pursuant to section 1 (3) of article V
16 of the state constitution against this act or an item, section, or part of this
17 act within such period, then the act, item, section, or part will not take
18 effect unless approved by the people at the general election to be held in
19 November 2026 and, in such case, will take effect on the date of the
20 official declaration of the vote thereon by the governor.
