A BILL FOR AN ACT

CONCERNING THE CREATION OF A PEER HEALTH ASSISTANCE PROGRAM FOR DENTAL HYGIENISTS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://leg.colorado.gov.)

The bill creates a peer health assistance program (program) for dental hygienists to assist dental hygienists with physical, emotional, or psychological problems that may be detrimental to the dental hygienist's ability to practice dental hygiene.

The program is funded by a fee each dental hygienist is required to pay upon renewal of the dental hygienist's license.

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, **add** 12-220-507 as 3 follows: 4 12-220-507. Dental hygienist peer health assistance program 5 - fees - rules. (1) (a) (I) EFFECTIVE JULY 1, 2022, AS A CONDITION OF 6 RENEWAL IN THIS STATE, EVERY DENTAL HYGIENIST APPLYING TO RENEW 7 THE DENTAL HYGIENIST'S LICENSE MUST PAY TO THE ADMINISTERING 8 ENTITY THAT HAS BEEN SELECTED BY THE BOARD PURSUANT TO 9 SUBSECTION (1)(c) OF THIS SECTION AN AMOUNT NOT TO EXCEED ELEVEN 10 DOLLARS PER YEAR. THE BOARD MAY ADJUST THIS AMOUNT ON JANUARY 11 1, 2023, AND ANNUALLY THEREAFTER TO REFLECT CHANGES IN THE 12 UNITED STATES DEPARTMENT OF LABOR, BUREAU OF LABOR STATISTICS, 13 CONSUMER PRICE INDEX FOR DENVER-AURORA-LAKEWOOD FOR ALL 14 URBAN CONSUMERS OR GOODS, OR ITS SUCCESSOR INDEX; EXCEPT THAT 15 THE AMOUNT MUST NOT EXCEED TWENTY-FIVE DOLLARS PER YEAR. 16 THE ADMINISTERING ENTITY SHALL USE THE MONEY 17 COLLECTED PURSUANT TO THIS SUBSECTION (1)(a) TO ADMINISTER A PEER 18 HEALTH ASSISTANCE PROGRAM FOR DENTAL HYGIENISTS, INCLUDING TO 19 SUPPORT DESIGNATED PROVIDERS THAT THE BOARD SELECTS PURSUANT 20 TO SUBSECTION (1)(b) OF THIS SECTION TO ASSIST DENTAL HYGIENISTS 21 WITH PHYSICAL, EMOTIONAL, OR PSYCHOLOGICAL PROBLEMS THAT MAY 22 BE DETRIMENTAL TO DENTAL HYGIENISTS' ABILITY TO PRACTICE DENTAL 23 HYGIENE. 24 THE BOARD SHALL SELECT ONE OR MORE PEER HEALTH 25 ASSISTANCE PROGRAMS AS DESIGNATED PROVIDERS. 1 IN A PEER HEALTH ASSISTANCE PROGRAM SHALL ENTER INTO A WRITTEN 2 AGREEMENT WITH THE BOARD PRIOR TO THE DENTAL HYGIENIST 3 BECOMING A PARTICIPANT IN THE PROGRAM. THE AGREEMENT MUST 4 CONTAIN SPECIFIC REQUIREMENTS AND GOALS TO BE MET BY THE 5 PARTICIPANT, INCLUDING THE CONDITIONS UNDER WHICH THE PROGRAM 6 WILL BE SUCCESSFULLY COMPLETED OR TERMINATED, A PROVISION 7 REOUIRING A PARTICIPATING DENTAL HYGIENIST TO PROMPTLY REPORT TO 8 THE BOARD A FAILURE TO COMPLY WITH THE REQUIREMENTS AND GOALS, 9 AND A PROVISION SPECIFYING THAT FAILURE TO COMPLY WITH THE 10 REOUIREMENTS AND GOALS RESULTS IN DISCIPLINARY ACTION BY THE 11 BOARD. 12 (b) Notwithstanding sections 12-220-201 and 24-4-104, the 13 BOARD MAY IMMEDIATELY SUSPEND THE LICENSE OF ANY DENTAL 14 HYGIENIST WHO IS REFERRED TO A PEER HEALTH ASSISTANCE PROGRAM BY 15 THE BOARD AND WHO FAILS TO ATTEND OR COMPLETE THE PROGRAM. IF 16 THE DENTAL HYGIENIST OBJECTS TO THE SUSPENSION, THE DENTAL 17 HYGIENIST MAY SUBMIT A WRITTEN REQUEST TO THE BOARD FOR A 18 FORMAL HEARING ON THE SUSPENSION WITHIN TEN DAYS AFTER RECEIVING 19 NOTICE OF THE SUSPENSION, AND THE BOARD SHALL GRANT THE REQUEST. 20 IN THE HEARING, THE DENTAL HYGIENIST BEARS THE BURDEN OF PROVING 21 THAT THE DENTAL HYGIENIST'S LICENSE SHOULD NOT BE SUSPENDED. 22 (c) ANY DENTAL HYGIENIST WHO IS ACCEPTED INTO A PEER 23 HEALTH ASSISTANCE PROGRAM IN LIEU OF DISCIPLINARY ACTION BY THE 24 BOARD SHALL AFFIRM THAT, TO THE BEST OF THE DENTAL HYGIENIST'S 25 KNOWLEDGE, INFORMATION, AND BELIEF, THE DENTAL HYGIENIST KNOWS 26 OF NO INSTANCE IN WHICH THE DENTAL HYGIENIST HAS VIOLATED THIS 27 ARTICLE 220 OR THE RULES OF THE BOARD, EXCEPT IN THOSE INSTANCES

AFFECTED BY THE DENTAL HYGIENIST'S PHYSICAL, EMOTIONAL, OR PSYCHOLOGICAL PROBLEMS.

(3) If a dental hygienist is arrested for a drug- or ALCOHOL-RELATED OFFENSE, THE DENTAL HYGIENIST SHALL SELF-REFER TO THE PEER HEALTH ASSISTANCE PROGRAM WITHIN THIRTY DAYS AFTER THE ARREST FOR AN EVALUATION AND REFERRAL FOR TREATMENT AS NECESSARY. IF THE DENTAL HYGIENIST SELF-REFERS, THE EVALUATION BY THE PROGRAM IS CONFIDENTIAL AND CANNOT BE USED AS EVIDENCE IN ANY PROCEEDING OTHER THAN BEFORE THE BOARD. IF A DENTAL HYGIENIST FAILS TO COMPLY WITH THIS SUBSECTION (3), THE FAILURE ALONE IS NOT GROUNDS FOR DISCIPLINE UNDER SECTIONS 12-220-201 AND 12-220-202 UNLESS THE DENTAL HYGIENIST HAS ALSO COMMITTED AN ACT OR OMISSION SPECIFIED IN SECTION 12-220-201, OTHER THAN AN ACT OR OMISSION SPECIFIED IN SECTION 12-220-201 (1)(e) OR (1)(f).

(4) NOTHING IN THIS SECTION CREATES ANY LIABILITY ON BEHALF OF THE BOARD OR THE STATE OF COLORADO FOR THE ACTIONS OF THE BOARD MEMBERS IN MAKING GRANTS TO PEER ASSISTANCE PROGRAMS, AND NO CIVIL ACTION MAY BE BROUGHT OR MAINTAINED AGAINST THE BOARD OR THE STATE FOR AN INJURY ALLEGED TO HAVE BEEN THE RESULT OF THE ACTIVITIES OF ANY STATE-FUNDED PEER ASSISTANCE PROGRAM OR OF AN ACT OR OMISSION OF A DENTAL HYGIENIST PARTICIPATING IN OR REFERRED BY A STATE-FUNDED PEER ASSISTANCE PROGRAM. HOWEVER, THE STATE REMAINS LIABLE UNDER THE "COLORADO GOVERNMENTAL IMMUNITY ACT", ARTICLE 10 OF TITLE 24, IF AN INJURY ALLEGED TO HAVE BEEN THE RESULT OF AN ACT OR OMISSION OF A DENTAL HYGIENIST PARTICIPATING IN OR REFERRED BY A STATE-FUNDED PEER ASSISTANCE PROGRAM OCCURRED WHILE THE DENTAL HYGIENIST WAS PERFORMING

7	rules. (1) (a) Effective July 1, 2004, as a condition of renewal in this
8	state, every renewal applicant shall DENTIST APPLYING TO RENEW THE
9	DENTIST'S LICENSE MUST pay to the administering entity that has been
10	selected by the board pursuant to subsection (1)(b) of this section an
11	amount not to exceed fifty-nine dollars per year, which maximum amount
12	may be adjusted on January 1, 2005, and annually thereafter by the board
13	to reflect changes in the United States department of labor, bureau of
14	labor statistics, consumer price index for Denver-Aurora-Lakewood for
15	all urban consumers or goods, or its successor index. The fee shall be
16	used to support designated providers that have been selected by the board
17	to provide assistance to dentists needing help in dealing with physical,
18	emotional, or psychological problems that may be detrimental to their
19	ability to practice dentistry. The fee shall not exceed one hundred dollars
20	per year per licensee.
21	SECTION 3. Safety clause. The general assembly hereby finds,
22	determines, and declares that this act is necessary for the immediate
23	preservation of the public peace, health, or safety.
