A BILL FOR AN ACT 101 CONCERNING THE PROHIBITION ON A POLITICAL SUBDIVISION 102 PLEDGING BUSINESS PERSONAL PROPERTY TAX REVENUE TO PAY 103 FUTURE FINANCIAL OBLIGATIONS.

Bill Summary

Beginning September 1, 2014, the bill prohibits a political subdivision, which includes counties, municipalities, special districts, and school districts, from pledging any revenues from the property tax levied on business personal property for the payment of interest or principal

owed on any type of bond or for the repayment of any other multiple-fiscal year debt or other obligation that requires voter approval.

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, add 39-1-123 as 3 follows: 4 39-1-123. Business personal property revenue - pledging for 5 bonds - prohibition. NOTWITHSTANDING ANY OTHER PROVISION OF LAW, 6 BEGINNING SEPTEMBER 1, 2014, A POLITICAL SUBDIVISION MAY NOT 7 PLEDGE ANY REVENUES FROM THE PROPERTY TAX LEVIED ON BUSINESS 8 PERSONAL PROPERTY FOR THE PAYMENT OF INTEREST OR PRINCIPAL OWED 9 ON ANY TYPE OF BOND OR FOR THE PAYMENT OF ANY OTHER 10 MULTIPLE-FISCAL YEAR DIRECT OR INDIRECT DEBT OR OTHER FINANCIAL 11 OBLIGATION THAT REQUIRES VOTER APPROVAL UNDER SECTION 20 (4) (b) 12 OF ARTICLE X OF THE STATE CONSTITUTION. 13 **SECTION 2.** Act subject to petition - effective date. This act 14 takes effect at 12:01 a.m. on the day following the expiration of the 15 ninety-day period after final adjournment of the general assembly (August 6, 2014, if adjournment sine die is on May 7, 2014); except that, if a 16 17 referendum petition is filed pursuant to section 1 (3) of article V of the 18 state constitution against this act or an item, section, or part of this act 19 within such period, then the act, item, section, or part will not take effect 20 unless approved by the people at the general election to be held in 21 November 2014 and, in such case, will take effect on the date of the 22 official declaration of the vote thereon by the governor.
