A BILL FOR AN ACT

101 **CONCERNING THE BREAST AND CERVICAL CANCER PREVENTION AND**
102 **TREATMENT FUND, AND, IN CONNECTION THEREWITH, MAKING**
103 **AN APPROPRIATION.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. For the 2024-25 state fiscal year, the bill transfers \$500,000 from the breast and cervical cancer prevention and treatment fund to the breast cancer screening fund. The bill also removes a requirement that the state treasurer transfer interest and income earned on money in the breast and cervical cancer prevention and treatment fund to the disability support

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 25-4-1503, **amend**
3 (1) as follows:

4 **25-4-1503. Fund created.** (1) There is ~~hereby~~ established in the
5 state treasury a ~~fund to be known as~~ the breast cancer screening fund,
6 which ~~shall be~~ IS subject to annual appropriation to the department for the
7 purposes of this part 15. The fund shall be credited with such
8 appropriations as the general assembly may make from the general fund
9 for the purposes of this part 15, ~~as well as any moneys~~ MONEY received
10 by the department pursuant to section 25-4-1505 (2) and (4), AND MONEY
11 TRANSFERRED TO THE FUND PURSUANT TO SECTION 25.5-5-308 (9)(h). In
12 accordance with section 24-36-114, ~~C.R.S.~~, all interest derived from the
13 deposit and investment of ~~this~~ THE fund ~~shall be~~ IS credited to the general
14 fund.

15 **SECTION 2.** In Colorado Revised Statutes, 25.5-5-308, **amend**
16 (8)(a)(I); **repeal** (8)(b.5); and **add** (9)(h) as follows:

17 **25.5-5-308. Breast and cervical cancer prevention and**
18 **treatment program - creation - legislative declaration - definitions -**
19 **funds - repeal.** (8) (a) (I) There is ~~hereby~~ created in the state treasury the
20 breast and cervical cancer prevention and treatment fund, referred to in
21 this subsection (8) as the "fund". The fund ~~shall consist of any moneys~~
22 ~~credited thereto~~ CONSISTS OF MONEY CREDITED TO THE FUND pursuant to
23 section 24-22-115 (1); ~~C.R.S.~~, any gifts, grants, and donations; any
24 ~~moneys~~ MONEY appropriated ~~thereto~~ OR TRANSFERRED TO THE FUND by
25 the general assembly; and ~~moneys credited thereto~~ MONEY CREDITED TO

1 THE FUND pursuant to section 42-3-217.5 (3)(c). ~~C.R.S. Except as~~
2 ~~provided for in paragraph (b.5) of this subsection (8);~~ All moneys MONEY
3 credited to the fund and all interest and income earned on the moneys
4 MONEY in the fund ~~shall remain~~ REMAINS in the fund for the purposes set
5 forth in this section. Any unexpended and unencumbered moneys MONEY
6 remaining in the fund at the end of a fiscal year ~~shall remain~~ REMAINS in
7 the fund and shall not be credited or transferred to the general fund or
8 another fund. The state department is encouraged to secure private gifts,
9 grants, and donations to fund the state costs of the breast and cervical
10 cancer prevention and treatment program.

11 (b.5) ~~Until section 24-30-2204.5 is repealed, the state treasurer~~
12 ~~shall transfer any interest or income earned on moneys in the fund to the~~
13 ~~disability support fund, created in section 24-30-2205.5.~~

14 (9) (h) FOR THE 2024-25, 2025-26, AND 2026-27 STATE FISCAL
15 YEARS, THE STATE TREASURER SHALL TRANSFER FIVE HUNDRED
16 THOUSAND DOLLARS FROM THE FUND TO THE BREAST CANCER SCREENING
17 FUND CREATED IN SECTION 25-4-1503.

18 **SECTION 3.** In Colorado Revised Statutes, 24-30-2205.5,
19 **amend** (1) as follows:

20 **24-30-2205.5. Disability support fund.** (1) There is hereby
21 created in the state treasury the disability support fund, which ~~shall~~
22 ~~consist~~ CONSISTS of ~~money transferred to the fund in accordance with~~
23 ~~section 25.5-5-308 (8), C.R.S., from the sale of registration numbers~~
24 ~~under this part 22,~~ any money that may be appropriated to the fund by the
25 general assembly and any gifts, grants, or donations received by the
26 department of personnel for the purpose of implementing this part 22.

27 **SECTION 4. Appropriation.** For the 2024-25 state fiscal year,

1 \$500,000 is appropriated to the department of public health and
2 environment for use by the prevention services division. This
3 appropriation is from the breast cancer screening fund created in section
4 25-4-1503, C.R.S. To implement this act, the department may use this
5 appropriation for breast and cervical cancer screening program.

6 **SECTION 5. Safety clause.** The general assembly finds,
7 determines, and declares that this act is necessary for the immediate
8 preservation of the public peace, health, or safety or for appropriations for
9 the support and maintenance of the departments of the state and state
10 institutions.
