A BILL FOR AN ACT CONCERNING RESTRICTIONS ON THE ABILITY OF A COUNTY GOVERNMENT TO EXERCISE ITS EMINENT DOMAIN POWERS FOR THE ACQUISITION OF OPEN SPACE.

Bill Summary

The bill prohibits a county government from either:

! Acquiring by condemnation property located within its territorial boundaries for the purpose of parks, recreation, open space, conservation, preservation of views or scenic vistas, or for similar purposes; or

Providing funding, in whole or in part, to any other public or private party for the acquisition by condemnation of property located within its territorial boundaries for the purpose of parks, recreation, open space, conservation, preservation of views or scenic vistas, or for similar purposes.

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, 38-1-101, add (4.5) 3 as follows: 4 38-1-101. Compensation - public use - commission - jury -5 court - prohibition on elimination of nonconforming uses or 6 nonconforming property design by amortization - limitation on 7 extraterritorial condemnation by municipalities - limitation on condemnation by counties for open space - definitions. 8 9 (4.5) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, IN ORDER TO 10 FURTHER PROTECT PRIVATE PROPERTY RIGHTS IN ACCORDANCE WITH THE 11 FEDERAL AND STATE CONSTITUTIONS AND THIS SECTION, WITHOUT THE 12 CONSENT OF THE OWNER OF THE PROPERTY, A COUNTY SHALL NOT: 13 (a) ACQUIRE BY CONDEMNATION PROPERTY LOCATED WITHIN ITS 14 TERRITORIAL BOUNDARIES FOR THE PURPOSE OF PARKS, RECREATION, 15 OPEN SPACE, CONSERVATION, PRESERVATION OF VIEWS OR SCENIC VISTAS, 16 OR SIMILAR PURPOSES; OR 17 (b) PROVIDE FUNDING, IN WHOLE OR IN PART, TO ANY OTHER 18 PUBLIC OR PRIVATE PARTY FOR THE ACQUISITION BY CONDEMNATION OF 19 PROPERTY LOCATED WITHIN ITS TERRITORIAL BOUNDARIES FOR THE 20 PURPOSE OF PARKS, RECREATION, OPEN SPACE, CONSERVATION, 21 PRESERVATION OF VIEWS OR SCENIC VISTAS, OR SIMILAR PURPOSES.

21	determines, and declares that this act is necessary for the immediate
22	preservation of the public peace, health, and safety.
