### A BILL FOR AN ACT

101 CONCERNING EXPANDING THE AVAILABILITY OF EARLY CHILDHOOD 102 HOME VISITING PROGRAMS TO SUPPORT SCHOOL READINESS.

### **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <a href="http://leg.colorado.gov">http://leg.colorado.gov</a>.)

The bill creates the home visiting expansion grant program (grant program) in the department of human services (department). The purpose of the grant program is to expand the number of children and families served by nationally recognized, evidence-based home visiting models (models) throughout the state and thus improve school readiness of Colorado children. The grant program has 2 cycles of 3 years each and

shall award up to a total of \$2 million in grants for each cycle, payable in equal annual amounts.

The state board of human services is authorized to promulgate rules that specify the criteria for the grant program, including eligibility of applicants and models, timeline, and review and selection criteria.

The department is required to prepare an evaluation report at the conclusion of each grant cycle and present that report as part of its next "SMART Act" report to its committee of reference.

The grant program is repealed, effective September 1, 2028.

1	Be it enacted by the General Assembly of the State of Colorado:
2	<b>SECTION 1. Legislative declaration.</b> (1) The general assembly
3	declares that:
4	(a) All families need additional support following the birth of a
5	child and during the early childhood years in order to foster strong
6	caregiver and child relationships and healthy child development;
7	(b) A child's first experiences and relationships set the foundation
8	for development and learning that leads to success in school and later in
9	life;
10	(c) Research on the brain development of young children
11	demonstrates that the most rapid period of brain development occurs
12	between zero and three years of age and that the foundations of healthy
13	social, emotional, and cognitive development are constructed during those
14	early years;
15	(d) For a child to be ready to successfully enter kindergarten,
16	school readiness needs to equally address three components:
17	(I) The readiness of the child;
18	(II) The readiness of the school; and
19	(III) The readiness of the family and community to support the
20	child's success; and

(e) As an essential component of the early care and learning system, family support programs have successfully demonstrated the ability to address outcomes associated with improving school readiness, including promoting solid parent-child relationships, improving child social-emotional and physical health, identifying developmental delays early, providing early intervention services, and preventing trauma and toxic stress.

- (2) (a) The general assembly further finds that, in particular, voluntary, high-quality, and evidence-based home visiting programs support parents to develop the skills and confidence needed to promote their child's healthy development and learning by meeting families in a location of the family's choosing.
- (b) The home visiting system and home visiting programs are a strategy that can be leveraged to provide early supportive services to more Colorado families with fewer resources and exposed to risk factors that may lead to poor developmental outcomes. By doing so, the home visiting system and home visiting programs can support Colorado's children in reaching their full potential and being ready for school.
- (c) Many home visiting programs that are currently being administered in Colorado have met the Level 5 evidence criteria as documented in the evidence continuum utilized by the governor's office of state planning and budgeting.
- (d) Colorado studies have found a benefit of \$1.50 to \$6.10 for every dollar spent on evidence-based home visiting programs delivered in Colorado.
- (3) Therefore, the general assembly declares that investing early in the home visiting system and home visiting programs is one of the best

official declaration of the vote thereon by the governor.
