## **Bill Summary**

Under current law, the private occupational school board (board) establishes criteria that a private occupational school shall meet prior to the board issuing a certificate of approval to operate in Colorado. The minimum standards that the board shall require is established in statute.

SENATE 2nd Reading Unamended March 3, 2014 The bill removes a statutory provision that exempts the board from having to observe and require compliance with certain statutory standards if the private occupational school is accredited by an accrediting association officially recognized by the United States department of education or by the board, so long as the accrediting body's standards meet or exceed the minimum standards set forth in statute.

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, 12-59-106, repeal (2) 3 as follows: 4 12-59-106. Minimum standards. (2) A school that is accredited 5 by an accrediting association officially recognized by the United States 6 education department or by the board may fulfill the requirements of 7 paragraphs (c) to (o) and (s) of subsection (1) of this section by 8 maintaining its accreditation with its appropriate accrediting association 9 as long as the accrediting standards meet or exceed the minimum 10 standards set forth in this article. 11 **SECTION 2. Safety clause.** The general assembly hereby finds, 12 determines, and declares that this act is necessary for the immediate 13 preservation of the public peace, health, and safety.
