1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 2-3-1203, **repeal** (3)  
3 (z.5) (II) as follows:

4 **2-3-1203. Sunset review of advisory committees.** (3) The  
5 following dates are the dates for which the statutory authorization for the  
6 designated advisory committees is scheduled for repeal:

10 **SECTION 2.** In Colorado Revised Statutes, 22-82.6-104, **amend**  
11 **(2) (a), (3) (a), (3) (d), and (4); and add (3) (f) as follows:**

12 **22-82.6-104. Interagency farm-to-school coordination task**  
13 **force - creation - repeal.** (2) (a) The task force consists of ~~thirteen~~  
14 ~~FIFTEEN~~ members as follows:

15 (I) The commissioner of education or the commissioner's  
16 designee;

17 (II) The commissioner of agriculture or the commissioner's  
18 designee;

19 (III) The executive director of the department of public health and  
20 environment or the executive director's designee;

21 (IV) The executive director of the Colorado commission on higher  
22 education or the executive director's designee, FROM, INCLUDING BUT NOT  
23 LIMITED TO, COLORADO UNIVERSITIES, COLLEGES, COMMUNITY COLLEGES,  
24 AND EXTENSIONS;

25 (V) The following five members as selected by the member  
26 -serving pursuant to subparagraph (I) of this paragraph (a):

27 (A) ~~Four~~ THREE representatives of school food service directors;

2 (B) A representative of parent LOCAL NONPROFIT COMMUNITY  
3 organizations engaged in farm to school or local food systems; and

4 (C) A PUBLIC SCHOOL TEACHER OR PRINCIPAL;

5 (VI) The following four FIVE members as selected by the member  
6 servng pursuant to subparagraph (II) of this paragraph (a):

7 (A) A representative of fruit and vegetable organizations;

8 (B) A representative of cattle ranching organizations;

9 (C) A representative of the western dairy association; and

10 (D) A representative of a food distribution association; AND

11 (E) A REPRESENTATIVE OF A FARM, ORCHARD, OR RANCH IN

12 COLORADO THAT SELLS PRODUCE, FRUIT, OR ANIMAL PRODUCTS TO AT

13 LEAST ONE COLORADO PUBLIC SCHOOL, SCHOOL DISTRICT, OR BOARD OF

14 COOPERATIVE SERVICES;

15 (VII) A REPRESENTATIVE OF SCHOOL FOOD SERVICES

16 MANAGEMENT FROM AN INSTITUTION OF HIGHER EDUCATION, SELECTED

17 BY THE MEMBER SERVING PURSUANT TO SUBPARAGRAPH (IV) OF THIS

18 PARAGRAPH (a); AND

19 (VIII) ANY NUMBER OF NONVOTING EX-OFFICIO MEMBERS AS

20 DESIGNATED BY A MAJORITY VOTE OF THE TASK FORCE.

21 (3) The task force shall study, develop, and recommend policies  
22 and methods to best implement a farm-to-school program, including:

23 (a) Creating ADVISING farm-to-school program pilots or  
24 expanding food focus education program pilots;

25 (d) Advising school districts on methods by which a school  
26 district may improve facilities to allow for the purchase and use of  
27 minimally processed and fresh and locally produced foods in school

1 meals; and

2 (f) EXPLORING VARIOUS STATEWIDE DATA COLLECTION SYSTEMS  
3 TO TRACK FARM-TO-SCHOOL ACTIVITIES.

4 (4) The task force shall report its progress, findings, and  
5 recommendations to the education committees of the house of  
6 representatives and the senate, the senate agriculture and natural resources  
7 committee, and the house agriculture, livestock, and natural resources  
8 committee, or any successor committees, on or before February 1, 2013  
9 2015, AND EVERY FEBRUARY 1 EVERY TWO YEARS THEREAFTER.

10 **SECTION 3.** In Colorado Revised Statutes, 22-82.6-104, **repeal**  
11 (5).

12 **SECTION 4. Safety clause.** The general assembly hereby finds,  
13 determines, and declares that this act is necessary for the immediate  
14 preservation of the public peace, health, and safety.
