advisory committee (committee). The bill reduces the committee to 7 members by eliminating one of 2 dentists providing dental care to seniors and one senior eligible for benefits, and by authorizing one member of the committee to represent either the department of human services or an agency that coordinates dental services to low-income seniors rather than each having a member.

The bill eliminates the repeal of the committee.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 25-21-107.5, **amend**  
3 (1); and **repeal** (3) as follows:

4 **25-21-107.5. Dental advisory committee - creation.** (1) ~~There~~  
5 ~~is hereby created~~ SUBJECT TO AVAILABLE APPROPRIATIONS, THE  
6 EXECUTIVE DIRECTOR MAY CREATE in the department a dental advisory  
7 committee ~~which shall be appointed by the governor. The dental advisory~~  
8 ~~committee shall be~~ comprised of ~~ten~~ SEVEN members APPOINTED BY THE  
9 GOVERNOR, including one member representing the department who shall  
10 be a nonvoting member, ~~one member representing the department of~~  
11 ~~human services, two dentists~~ ONE DENTIST providing dental care to the  
12 senior population, one dental hygienist, one representative of EITHER THE  
13 DEPARTMENT OF HUMAN SERVICES OR an agency that coordinates services  
14 for low-income seniors, one dentist in private practice who represents the  
15 professional dental association, one representative from a dental school,  
16 and ~~two~~ ONE eligible seniors. ~~The members of the advisory committee~~  
17 ~~shall be appointed by July 1, 2003~~ SENIOR. Of the members initially  
18 appointed to the advisory committee, ~~five~~ FOUR shall be appointed for  
19 two-year terms and ~~five~~ THREE shall be appointed for three-year terms. In  
20 the event of a vacancy on the advisory committee, the governor shall  
21 appoint a successor to fill the unexpired portion of the term of such
