A BILL FOR AN ACT

101 **CONCERNING THE CREATION OF THE COLORADO CAREER ADVISOR**
102 **TRAINING PROGRAM, AND, IN CONNECTION THEREWITH, MAKING**
103 **AN APPROPRIATION.**

Bill Summary

The bill creates the Colorado career advisor training program in the department of education (department) to provide training to career advisors in Colorado. The department administers the program. The bill creates in the department the Colorado advisor training program fund (fund) and appropriates one million dollars from the general fund to the

fund for purposes of the program.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1. Legislative declaration.** (1) The general assembly
3 finds that:

4 (a) Career advising supports youth and adult learners by providing
5 essential information to help them navigate careers and jobs;

6 (b) Many students and adult learners in Colorado do not know
7 what positions or credentials to pursue to secure high-paying jobs, and
8 they have difficulty navigating Colorado's education, training, and
9 employment landscape;

10 (c) Career advisors exist in K-12, higher education, adult
11 education, and workforce settings;

12 (d) In 2019, as an education leadership council initiative,
13 Colorado developed a first-in-the-nation model called the Colorado
14 Career Conversations Training project to cross-train career advisors
15 across systems. As a result of COVID-19, funding for this project was
16 interrupted.

17 (e) The past two years have underscored the need for high-quality
18 professional development and training to help existing career advisors be
19 dynamic and understand the shifting landscape of our state and regional
20 job needs and skills; and

21 (f) Program evaluations showed that the Colorado Career
22 Conversations Training project resulted in a statewide expansion of
23 highly trained career advisors focused on high-need sectors of the
24 economy and built increased capacity for a more consistent and
25 sustainable approach to career advising in Colorado as a model for the

1 nation.

2 (2) Therefore, the general assembly declares that providing access
3 to quality career advisors can address Colorado's skill and credential
4 attainment gap by helping students and adult learners explore career
5 options and complete the necessary education and training to obtain
6 quality living-wage jobs in high-need sectors of Colorado's economy.

7 **SECTION 2.** In Colorado Revised Statutes, **add** 22-10-108 as
8 follows:

9 **22-10-108. Colorado career advisor training program -**
10 **creation - fund - definition.** (1) AS USED IN THIS SECTION, UNLESS THE
11 CONTEXT OTHERWISE REQUIRES, "COLORADO CAREER ADVISOR" MEANS
12 A SCHOOL COUNSELOR, AS DEFINED IN SECTION 22-91-102 (6); ADULT
13 EDUCATION ADVISOR; NONPROFIT CAREER ADVISOR; WORKFORCE CENTER
14 ADVISOR; OR HIGHER EDUCATION ADVISOR.

15 (2) THERE IS CREATED THE COLORADO CAREER ADVISOR TRAINING
16 PROGRAM IN THE OFFICE TO PROVIDE TRAINING PROGRAMS AND COURSES
17 TO COLORADO CAREER ADVISORS IN AN EFFORT TO EQUIP COLORADO
18 CAREER ADVISORS WITH THE SKILLS AND TRAINING NECESSARY TO HELP
19 GUIDE INDIVIDUALS TOWARD MEANINGFUL CAREERS.

20 (3) THE DEPARTMENT, IN COORDINATION WITH THE DEPARTMENT
21 OF HIGHER EDUCATION, DEPARTMENT OF LABOR AND EMPLOYMENT,
22 COLORADO WORKFORCE DEVELOPMENT COUNCIL, AND THE COLORADO
23 COMMUNITY COLLEGE SYSTEM, SHALL ADMINISTER THE COLORADO
24 CAREER ADVISOR TRAINING PROGRAM. THE DEPARTMENT SHALL SELECT
25 THOSE ENTITIES THAT WILL RECEIVE GRANTS THROUGH THE COLORADO
26 CAREER ADVISOR TRAINING PROGRAM AND THE AMOUNT OF EACH GRANT.
27 IN ADDITION, THE DEPARTMENT SHALL MONITOR THE EFFECTIVENESS OF

1 PROGRAMS THAT RECEIVE FUNDS THROUGH THE COLORADO CAREER
2 ADVISOR TRAINING PROGRAM. TO BE ELIGIBLE FOR GRANTS FROM THE
3 DEPARTMENT FOR THE PROVISION OF CAREER ADVISOR TRAINING FOR
4 COLORADO CAREER ADVISORS, AN ENTITY MUST APPLY TO THE
5 DEPARTMENT IN ACCORDANCE WITH THE TIMELINES AND GUIDELINES
6 ADOPTED BY THE DEPARTMENT.

7 (4) FOR STATE FISCAL YEAR 2022-23, THE GENERAL ASSEMBLY
8 SHALL APPROPRIATE ONE MILLION DOLLARS FROM THE GENERAL FUND TO
9 THE DEPARTMENT FOR THE COLORADO CAREER ADVISOR TRAINING
10 PROGRAM. ==

11 **SECTION 3. Appropriation.** For the 2022-23 state fiscal year,
12 \$1,000,000 is appropriated to the department of education. This
13 appropriation is from the general fund. To implement this act, the
14 department may use this appropriation for the Colorado career advisor
15 training program.

16 **SECTION 4. Safety clause.** The general assembly hereby finds,
17 determines, and declares that this act is necessary for the immediate
18 preservation of the public peace, health, or safety.
