SENATE BILL 10-172

CONCERNING THE CONTINUATION OF VOLUNTARY CONTRIBUTION
DESIGNATION LINES ON STATE INDIVIDUAL INCOME TAX FORMS FOR
CERTAIN FUNDS SET TO EXPIRE JANUARY 1, 2011.

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. 39-22-801, Colorado Revised Statutes, is amended to read:

39-22-801. Voluntary contribution designation - procedure. For income tax years commencing on or after ~~January 1, 2000~~, but prior to January 1, 2010, BUT PRIOR TO JANUARY 1, 2020, each Colorado state individual income tax return form shall contain a line whereby each individual taxpayer may designate the amount of the contribution, if any, the taxpayer wishes to make to the Colorado domestic abuse program fund created in section 39-22-802.

SECTION 2. 39-22-803, Colorado Revised Statutes, is amended to read:

Capital letters indicate new material added to existing statutes; dashes through words indicate deletions from existing statutes and such material not part of act.

39-22-803. Repeal of part. This part 8 is repealed, effective ~~January 1, 2011~~ JANUARY 1, 2021, unless the voluntary contribution to the Colorado domestic abuse program fund established in section 39-22-802 is continued or reestablished by the general assembly acting by bill prior to said date.

SECTION 3. 39-22-2201, Colorado Revised Statutes, is amended to read:

39-22-2201. Voluntary contribution designation - procedure. For income tax years commencing on or after ~~January 1, 2007, but prior to~~ January 1, 2010, BUT PRIOR TO JANUARY 1, 2020, each Colorado state individual income tax return form shall contain a line whereby each individual taxpayer may designate the amount of the contribution, if any, the taxpayer wishes to make to the pet overpopulation fund.

SECTION 4. 39-22-2203, Colorado Revised Statutes, is amended to read:

39-22-2203. Repeal of part. This part 22 is repealed, effective ~~January 1, 2011~~ JANUARY 1, 2021, unless the voluntary contribution to the pet overpopulation fund established by section 39-22-2201 is continued or reestablished by the general assembly acting by bill prior to said date.

SECTION 5. 39-22-3302, Colorado Revised Statutes, is amended to read:

39-22-3302. Voluntary contribution designation - procedure. For income tax years commencing on or after ~~January 1, 2007, but prior to~~ January 1, 2010, BUT PRIOR TO JANUARY 1, 2020, the Colorado state individual income tax return form shall contain a line whereby each individual taxpayer may designate the amount of the contribution, if any, the individual wishes to make to the Colorado breast and women's reproductive cancers fund created in section 39-22-3303.

SECTION 6. 39-22-3304, Colorado Revised Statutes, is amended to read:

39-22-3304. Repeal of part. This part 33 is repealed, effective

~~January 1, 2011~~ JANUARY 1, 2021, unless the voluntary contribution to the Colorado breast and women's reproductive cancers fund established by section 39-22-3303 is continued or reestablished by the general assembly acting by bill prior to said date.

SECTION 7. Act subject to petition - effective date. This act shall take effect at 12:01 a.m. on the day following the expiration of the ninety-day period after final adjournment of the general assembly (August 11, 2010, if adjournment sine die is on May 12, 2010); except that, if a referendum petition is filed pursuant to section 1 (3) of article V of the state constitution against this act or an item, section, or part of this act within such period, then the act, item, section, or part shall not take effect unless

approved by the people at the general election to be held in November 2010 and shall take effect on the date of the official declaration of the vote thereon by the governor.
