A BILL FOR AN ACT

101 **CONCERNING THE CONTINUATION OF PROGRAMS BENEFITING THE**
102 **PRESERVATION OF WILDLIFE HABITAT, AND, IN CONNECTION**
103 **THEREWITH, CONTINUING THE WILDLIFE HABITAT STAMP**

Bill Summary

The bill continues the wildlife habitat stamp committee indefinitely by deleting its repeal scheduled for December 31, 2013. The

bill eliminates the Colorado wildlife passport and the Colorado wildlife passport fund. The parks and wildlife commission is directed to use revenues from the wildlife habitat stamp to give sufficient priority to conserve and protect winter range and vital habitats, including migration corridors, for deer, elk, and other big game wildlife species; to improve public access for hunting, access for anglers to the waters of the state, and access for other wildlife-related recreation; to protect habitat for species of concern; and to preserve the diversity of wildlife.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 2-3-1203, **repeal** (3)
3 (z.5) (I); and **add** (3) (jj) (I) as follows:

4 **2-3-1203. Sunset review of advisory committees.** (3) The
5 following dates are the dates for which the statutory authorization for the
6 designated advisory committees is scheduled for repeal:

7 (z.5) December 31, 2013:

13 **SECTION 2.** In Colorado Revised Statutes, 33-4-102.7, **amend**
14 (1) (c), (4) (a), (4) (d), and (8) (a); and **repeal** (4) (b), (6), and (9) as
15 follows:

16 **33-4-102.7. Colorado wildlife habitat stamp - review**
17 **committee - rules - study - repeal.** (1) The general assembly hereby
18 finds, determines, and declares that:

19 (c) Priorities for the expenditure of funds generated from the sale
20 of habitat stamps and Colorado wildlife passports shall include protecting
21 big game winter range and migration corridors, acquiring public access

1 to wildlife-related recreation, including fishing, hunting, and wildlife
2 viewing, protecting habitat for species of concern, and preserving the
3 diversity of wildlife enjoyed by Coloradans.

4 (4) (a) ~~(H)~~ All moneys received pursuant to the issuance of the
5 Colorado wildlife habitat stamp shall be used for the benefit of wildlife
6 habitat or access to wildlife habitat, including costs associated with the
7 operation and maintenance, such as weed control and fencing, of THOSE
8 lands PURCHASED IN FEE SIMPLE BY THE DIVISION OR THOSE ACCESS
9 EASEMENTS ACQUIRED BY THE DIVISION under the Colorado wildlife
10 habitat protection program. Revenues collected from the sale of the stamp
11 are subject to annual appropriation. The Colorado wildlife habitat stamp
12 review committee shall annually review proposed projects for expenditure
13 of Colorado wildlife habitat stamp funds ~~including projects proposed~~
14 ~~pursuant to subparagraph (H) of this paragraph (a)~~, and make
15 recommendations to the director and the commission. In consultation with
16 the habitat stamp committee, the commission shall, in its discretion,
17 ensure that, IN THE ALLOCATION OF REVENUES UNDER THIS SECTION,
18 sufficient priority is given ~~to improve access for anglers to the waters of~~
19 ~~the state and~~ to conserve and protect winter range and vital habitats,
20 INCLUDING MIGRATION CORRIDORS, for deer, elk, and other big game
21 wildlife species; ~~in the allocation of revenues pursuant to this section~~ TO
22 IMPROVE PUBLIC ACCESS FOR HUNTING, ACCESS FOR ANGLERS TO THE
23 WATERS OF THE STATE, AND ACCESS FOR OTHER WILDLIFE-RELATED
24 RECREATION; TO PROTECT HABITAT FOR SPECIES OF CONCERN; AND TO
25 PRESERVE THE DIVERSITY OF WILDLIFE ENJOYED BY COLORADANS.

26 ~~(H) Five hundred thousand dollars of moneys received from~~
27 ~~issuance of Colorado wildlife habitat stamps shall be made available~~

1 ~~annually for use by the Colorado water conservation board for the~~
2 ~~purposes and under such conditions described in this subparagraph (H).~~
3 ~~In order to qualify for habitat stamp moneys under this subparagraph (H),~~
4 ~~the Colorado water conservation board must have expended all moneys~~
5 ~~available for the costs of acquiring water, water rights, and interests in~~
6 ~~water for instream flow use from the moneys appropriated from the~~
7 ~~Colorado water conservation board construction fund for the current~~
8 ~~fiscal year pursuant to section 37-60-123.7, C.R.S. In such case, the~~
9 ~~Colorado water conservation board shall apply to the commission and the~~
10 ~~director for all or a portion of the five hundred thousand dollars, as~~
11 ~~needed, to acquire water, water rights, or interests in water pursuant to~~
12 ~~section 37-92-102 (3), C.R.S., and subject to the limitations on~~
13 ~~expenditures set forth in section 37-60-123.7, C.R.S. The commission~~
14 ~~may approve the application if, in the judgment of the commission, it is~~
15 ~~necessary, suitable, or proper for wildlife purposes or for the preservation~~
16 ~~or conservation of wildlife. Any approval shall contain a stipulation that~~
17 ~~the Colorado water conservation board return any excess or unexpended~~
18 ~~habitat stamp moneys, which moneys shall then be used toward the~~
19 ~~purposes set forth in subparagraph (I) of this paragraph (a).~~

20 (b) ~~(I) On and after July 1, 2010, the commission is authorized to~~
21 ~~issue a Colorado wildlife passport, for which it may, by rule, charge a fee~~
22 ~~of not more than twenty-five dollars. The amount charged for such~~
23 ~~passport shall include three dollars for the purchase of a Colorado outdoor~~
24 ~~recreation search and rescue card.~~

25 ~~(H) There is hereby created in the state treasury the Colorado~~
26 ~~wildlife passport fund, referred to in this subparagraph (H) as the "fund",~~
27 ~~which fund shall consist of moneys received from issuance of Colorado~~

1 wildlife passports pursuant to subparagraph (I) of this paragraph (b) and
2 moneys otherwise donated to the habitat stamp program in the division.
3 Moneys in the fund are subject to annual appropriation and may be used
4 for costs associated with the operation and maintenance of lands under
5 the Colorado wildlife habitat protection program administered by the
6 division, to market sales of Colorado wildlife passports or otherwise
7 encourage contributions for habitat protection or enhancement, and for
8 the acquisition of interests in real property pursuant to paragraph (c) of
9 this subsection (4). Any balance remaining in the fund at the end of any
10 fiscal year shall remain in the fund and shall not be deposited in or
11 transferred to the general fund or any other fund.

12 (d) No third-party conservation easement shall be obtained using
13 proceeds from the sale of habitat stamps unless the requesting
14 organization contributes at least fifteen percent of the purchase price of
15 the easement or fifteen percent of the purchase price is secured using
16 other sources of nondivision funding; ~~except that, upon recommendation~~
17 ~~by the Colorado wildlife habitat stamp committee, the commission may~~
18 ~~approve the application of moneys from the Colorado wildlife passport~~
19 ~~fund pursuant to paragraph (b) of this subsection (4) toward all or a~~
20 ~~portion of said fifteen percent; however, if, in the commission's~~
21 ~~discretion, sufficient hunting or fishing access is provided, the fifteen~~
22 ~~percent contribution requirement may be waived.~~

23 (6) ~~The commission may enter into a contract with a nonprofit~~
24 ~~conservation organization for the purpose of providing the form and~~
25 ~~design of the Colorado wildlife habitat stamp. Such contract shall provide~~
26 ~~that such nonprofit conservation organization shall select a form and~~
27 ~~design. At least one of the alternative pieces of artwork considered for~~

1 final selection shall be the work of an artist who is a resident of Colorado.
2 In addition, such contract shall designate the ownership of the publication
3 rights for any art prints or other facsimiles of the Colorado wildlife
4 habitat stamp and the disposition of any proceeds. The division shall not
5 be an eligible contractor unless no contract can be negotiated with a
6 nonprofit conservation organization.

7 (8) (a) This section is repealed, effective December 31, 2013,
8 JULY 1, 2027.

9 (9) During the 2010 regular session of the general assembly, the
10 house agriculture, livestock, and natural resources committee and the
11 senate agriculture and natural resources committee, or their successor
12 committees, shall meet jointly to study this section and the issues raised
13 by the reengrossed version of Senate Bill 09-235. The committees shall
14 meet as often as necessary, and at least once prior to June 1, 2010.

15 **SECTION 3.** In Colorado Revised Statutes, 33-4-102, **repeal**
16 (1.6) (c) as follows:

17 **33-4-102. Types of licenses and fees - rules - repeal.**
18 (1.6) (c) The commission may, by appropriate rule, set fees for Colorado
19 wildlife passports pursuant to section 33-4-102.7 (4) (b) (I).

20 **SECTION 4.** In Colorado Revised Statutes, 37-60-123.7, **repeal**
21 (1.5) as follows:

22 **37-60-123.7. Acquisitions of water for instream flows.** (1.5) In
23 any year that the board expends all of the moneys available for the costs
24 of acquiring water, water rights, and interests in water for instream flow
25 use from the moneys that have been appropriated for the current fiscal
26 year from the Colorado water conservation board construction fund
27 pursuant to this section, the board shall apply to the parks and wildlife

2 ~~from habitat stamp moneys made available pursuant to section 33-4-102.7~~
3 ~~(4) (a) (H), C.R.S. Any habitat stamp moneys received shall be used to~~

5 ~~37-92-102 (3), subject to the limitations set forth in this section.~~

6 **SECTION 5. Safety clause.** The general assembly hereby finds,
7 determines, and declares that this act is necessary for the immediate
8 preservation of the public peace, health, and safety.
