A BILL FOR AN ACT CONCERNING THE ABILITY OF CERTAIN ORGANIZATIONS CONDUCTING A SPECIAL EVENT TO SELL ALCOHOL BEVERAGES FOR FUNDRAISING PURPOSES UNDER SPECIFIED CIRCUMSTANCES.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Senate Bill 18-067 (enacted in 2018) allows certain organizations conducting a special event to auction alcohol beverages in sealed containers if certain conditions were met. The bill expands on SB 18-067 by also allowing organizations conducting a special event to open the sealed containers and sell the alcohol beverages by the drink to persons

attending the special event, for consumption only on the licensed premises or unlicensed premises where the special event is held.

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, 12-47-107, amend 3 **as added by Senate Bill 18-067** (2)(a)(II) and (2)(b); and **add** (2)(a)(III) 4 and (2)(b.5) as follows: 5 12-47-107. Permitted acts - auctions at special events -6 **definition.** (2) (a) An organization that is holding a special event 7 pursuant to article 48 of this title 12 may, subject to the requirements of 8 subsection (2)(b) of this section: 9 (II) Auction the alcohol beverages in sealed containers for 10 fundraising purposes while on the licensed premises or unlicensed premises where the special event is held; AND 11 12 OPEN THE SEALED CONTAINERS AND SELL THE ALCOHOL 13 BEVERAGES BY THE DRINK TO PERSONS ATTENDING THE SPECIAL EVENT, 14 FOR CONSUMPTION ONLY ON THE LICENSED PREMISES OR UNLICENSED 15 PREMISES WHERE THE SPECIAL EVENT IS HELD. 16 (b) FOR ALCOHOL BEVERAGES AUCTIONED IN ACCORDANCE WITH 17 SUBSECTION (2)(a)(II) OF THIS SECTION: 18 (I) An organization holding a special event and, if the special 19 event is held on a licensed premises, the licensee on whose licensed 20 premises the special event is held, or, if the special event is held on 21 unlicensed premises, the person on whose unlicensed premises the special 22 event is held, shall ensure that any alcohol beverages in sealed containers 23 brought onto, auctioned at, or removed from the premises remain sealed 24 at all times while on the premises. 25 (II) The licensee on whose licensed premises the special event is

5	(b.5) FOR ALCOHOL BEVERAGES SOLD IN ACCORDANCE WITH
6	SUBSECTION (2)(a)(II) OF THIS SECTION, AN ORGANIZATION HOLDING A
7	SPECIAL EVENT AND, IF THE SPECIAL EVENT IS HELD ON A LICENSED
8	PREMISES, THE LICENSEE ON WHOSE LICENSED PREMISES THE SPECIAL
9	EVENT IS HELD, OR, IF THE SPECIAL EVENT IS HELD ON UNLICENSED
10	PREMISES, THE PERSON ON WHOSE UNLICENSED PREMISES THE SPECIAL
11	EVENT IS HELD, SHALL PROMPTLY REMOVE ALL OPEN AND UNCONSUMED

14	SECTION 2. In Colorado Revised Statutes, 12-47-901, add
15	(5)(i)(III) as follows:

17	unlawful for any person licensed to sell at retail pursuant to this article 47
18	or article 46 of this title 12:
19	(i) (III) NOTWITHSTANDING SUBSECTION (5)(i)(I) OF THIS SECTION,
20	IT IS NOT UNLAWFUL FOR AN ORGANIZATION HOLDING A SPECIAL EVENT
21	PURSUANT TO ARTICLE 48 OF THIS TITLE 12 TO SELL ALCOHOL BEVERAGES
22	FOR CONSUMPTION ON A LICENSED PREMISES OR UNLICENSED PREMISES
23	WHERE THE SPECIAL EVENT IS HELD IN ACCORDANCE WITH SECTION
24	12-47-107 (2).
25	SECTION 3. Safety clause. The general assembly hereby finds,
26	determines, and declares that this act is necessary for the immediate
27	preservation of the public peace, health, and safety.
