101 **CONCERNING GENDER-RELATED CHANGES TO CRIMES THAT INVOLVE**
102 **BIAS.**

Bill Summary

The bill adds gender identity and gender expression to the classes identified in bias-motivated crimes and harassment. The bill redefines sexual orientation for purposes of bias-motivated crimes as an individual's identity, or another individual's perception thereof, in relation to the gender or genders to which the individual is sexually or emotionally attracted and the behavior or social affiliation that may result from the

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 18-9-121, **amend (1),**
3 (2) introductory portion and (5)(b) as follows:

4 **18-9-121. Bias-motivated crimes - legislative declaration.**

5 (1) The general assembly hereby finds and declares that it is the right of
6 every person, regardless of race, color, ancestry, religion, national origin,
7 physical or mental disability, ~~or~~ sexual orientation, GENDER IDENTITY, OR
8 GENDER EXPRESSION to be secure and protected from fear, intimidation,
9 harassment, and physical harm caused by the activities of individuals and
10 groups. The general assembly further finds that the advocacy of unlawful
11 acts against persons or groups because of a person's or group's race, color,
12 ancestry, religion, national origin, physical or mental disability, ~~or~~ sexual
13 orientation, GENDER IDENTITY, OR GENDER EXPRESSION for the purpose of
14 inciting and provoking bodily injury or damage to property poses a threat
15 to public order and safety and should be subject to criminal sanctions.

16 (2) A person commits a bias-motivated crime if, with the intent to
17 intimidate or harass another person, in whole or in part, because of that
18 person's actual or perceived race; color; religion; ancestry; national
19 origin; physical or mental ~~disability; or~~ sexual orientation; ~~he or she~~
20 GENDER IDENTITY; OR GENDER EXPRESSION, THE PERSON:

21 (5) For purposes of this section:

22 (b) "Sexual orientation" means ~~a person's actual or perceived~~
23 ~~orientation toward heterosexuality, homosexuality, bisexuality, or~~
24 ~~transgender status~~ AN INDIVIDUAL'S IDENTITY, OR ANOTHER INDIVIDUAL'S
25 PERCEPTION THEREOF, IN RELATION TO THE GENDER OR GENDERS TO

1 WHICH THE INDIVIDUAL IS SEXUALLY OR EMOTIONALLY ATTRACTED AND
2 THE BEHAVIOR OR SOCIAL AFFILIATION THAT MAY RESULT FROM THE
3 ATTRACTION.

4 **SECTION 2.** In Colorado Revised Statutes, 18-9-111, **amend**
5 (2)(a) as follows:

6 **18-9-111. Harassment - Kiana Arellano's Law.** (2) (a) A
7 person who violates subsection (1)(a) or (1)(c) of this section or violates
8 any provision of subsection (1) of this section with the intent to intimidate
9 or harass another person, in whole or in part, because of that person's
10 actual or perceived race; color; religion; ancestry; national origin;
11 physical or mental disability, as defined in section 18-9-121; ~~(5)(a)~~; or
12 sexual orientation, as defined in section 18-9-121; ~~(5)(b)~~; GENDER
13 IDENTITY; OR GENDER EXPRESSION, commits a class 1 misdemeanor.

14 **SECTION 3. Effective date - applicability.** This act takes effect
15 July 1, 2024, and applies to offenses committed on or after said date.

16 **SECTION 4. Safety clause.** The general assembly finds,
17 determines, and declares that this act is necessary for the immediate
18 preservation of the public peace, health, or safety or for appropriations for
19 the support and maintenance of the departments of the state and state
20 institutions.
