A BILL FOR AN ACT

101 CONCERNING TECHNICAL MODIFICATIONS TO MISCELLANEOUS
102 PROVISIONS OF THE "UNIFORM ELECTION CODE OF 1992", AND,
103 IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill makes the following technical modifications to miscellaneous provisions of the "Uniform Election Code of 1992" (code):

! **Section 1** of the bill clarifies that any undeliverable message or any other message indicating that the elector's electronic-mail address is no longer valid does not need to

- be stored in the statewide voter registration system.
- ! **Section 2** specifies voter registration requirements pertaining to a homeless elector.
 - ! **Section 3** clarifies that existing requirements prohibiting a loss of voter registration status while a person is confined in a correctional facility, jail, or state institution apply when the person is not serving a sentence for a felony conviction. Section 3 also clarifies that existing requirements permitting a confined prisoner who is awaiting trial or has not been tried to register to vote also applies to a prisoner who is not serving a sentence for a felony conviction. This section further adds that all such prisoners may list their confinement location as their ballot address for voter registration purposes.
 - ! **Section 4** clarifies the text of certain questions an elector answers upon registering and adds as a question the address where the elector wishes to receive his or her ballot if different from the address of record.
 - ! **Section 5** makes changes to existing statutory provisions to facilitate the registration of electors at driver's license examination facilities.
 - ! **Section 6** specifies that a declaration or change of affiliation made by an unaffiliated elector must be deferred if the elector has already been mailed a primary election ballot packet. The deadline by which the elector must declare, change, or withdraw an affiliation only applies to a primary election and does not apply to a general or coordinated election.
 - ! **Section 7** requires the department of state, no later than July 31, 2019, to regularly provide the department of revenue (DOR) with current voter registration information. The DOR must use the information to determine whether an individual is registered to vote at the time he or she applies to obtain, renew, or update a driver's license or state identification card.
 - ! **Section 8** changes the deadlines for registering to vote in advance of a political party caucus, assembly, or convention and for affiliating with the political party in advance of such events.
 - ! **Section 9** requires the state central committee of each major political party to compile and provide to the secretary of state (secretary) information concerning the membership of the county central committees of the party in addition to the bylaws or rules of each county central committee.
 - ! **Section 10** prohibits an unaffiliated elector from signing a

- petition for a candidate of a major political party.
- ! **Section 11** prohibits a write-in vote for president in a general election from being counted unless it includes a write-in vote for vice-president.
 - ! **Section 12** deletes an existing statutory requirement that a copy of the notice of the cancellation of an election be posted at each voter service and polling center (VSPC) of the political subdivision.
 - ! **Section 13** repeals statutory language requiring the county clerk and recorder (county clerk) to prepare a combined primary election ballot to be used by unaffiliated electors.
 - ! **Section 14** clarifies the certification requirements for election judges such that they will be certifying that they are residents of the state and deletes language requiring them to certify that they reside in the political subdivision. Section 14 also changes the date in advance of an election when classes for training election or supervisor judges must be held.
 - ! **Section 15** changes the deadline by which the appropriate official of a minor political party must certify to the county clerk an initial list of the names and addresses of electors serving as election judges.
 - ! **Section 16** changes the deadline by which any unaffiliated elector may give notice to the county clerk offering to serve as an election judge.
 - ! **Sections 17, 18, and 19** replace the term "precinct" with "VSPC" in 3 statutory sections addressing election and supervisor judges. Section 17 requires the county clerk to appoint election judges for each location where election activities are occurring instead of for each precinct as under existing law. This section also permits the county clerk to appoint an election judge to serve in a county other than the county in which the election judge resides. If more than one supervisor judge is serving at a VSPC, section 19 also requires the judges to be of different political party affiliations.
 - ! **Section 20** replaces the term "polling location" with "VSPC" in a statutory section dealing with the number of election judges.
 - ! **Section 21** repeals an outdated statutory section requiring, where voting is by ballot or on a ballot card, a particular counting of the ballots and the sealing of the transfer box. Section 20 also repeals outmoded provisions concerning preparation of the paper tape in electronic voting.
 - ! **Section 22** changes the deadline by which comments

pertaining to a ballot issue must be filed with the political subdivision.

- ! **Section 23** changes, for referred ballot measures, the deadline by which petition representatives are required to submit to the political subdivision comments favorable to the petition.
- ! **Section 24** changes the deadline by which the designated election official of a political subdivision (DEO) is required to submit to the county clerk the full text of any required ballot issue notices.
- ! **Sections 25, 26, 27, and 29** eliminate the general requirement that a secrecy envelope or sleeve be included in a mail ballot packet. Section 26 also modifies the language used for instructing the elector on completing a mail ballot. Section 29 also requires the county clerk to ensure the privacy of each elector's vote when election judges are removing and separating marked ballots from return envelopes and specifies actions that must be taken by the county clerk if he or she chooses not to include a secrecy envelope or sleeve in the mail ballot packet.
- ! **Section 28** also changes the deadline by which a DEO is required to provide a mail ballot to a registered elector who requests the ballot at the DEO's office or the office designated in the mail ballot plan filed with the secretary.
- ! **Section 30** repeals statutory provisions governing the process of applying for an absentee ballot.
- ! **Section 31** provides that, if the declaration accompanying a federal write-in absentee ballot is received after the election, it is to be treated as an application to register to vote for subsequent elections.
- ! **Section 32** changes the deadline by which the DEO is to complete the verification and counting of all provisional ballots.
- ! **Section 33** changes the deadline by which the canvass board is to complete its duties.
- ! In the case of an election that includes a statewide ballot measure, **section 34** changes the deadline by which the county clerk is to transmit to the secretary the portion of the abstract of votes cast that contains the statewide abstract of votes cast. Section 34 also changes the deadline by which the secretary is to compile and total election returns, determine if a recount is necessary, and order any recounts.
- ! **Section 35** changes the deadline by which the canvass board is to certify to the DEO the official abstract of votes cast for all candidates and ballot measures in the election.

- ! **Section 36** deletes a requirement that the secretary notify the affected county clerk of a recount for congressional, state and district offices, state ballot questions, and state ballot issues by means of registered mail and facsimile transmission. Section 36 also changes the deadline for completing the recount.
- ! **Section 37** changes the deadline by which a recount of other offices, ballot issues, and ballot questions arising out of an election coordinated by the county clerk is to be completed and also changes another deadline affecting the notice to be given to the county clerk by a political subdivision where a recount is being waived.
- ! **Section 38** changes the deadlines by which an interested party is to submit a notarized written request for a recount and by which an automatic recount is to be completed.
- ! **Section 39** changes the manner of calculating the number of signatures required for a petition to recall a school district director.
- ! **Section 40** changes the deadline by which a signer may request that his or her name be stricken from a recall petition.

2 **SECTION 1.** In Colorado Revised Statutes, 1-1-110, **amend**
 3 (5)(c) as follows:

4 **1-1-110. Powers of county clerk and recorder and deputy -**
 5 **communication to electors.** (5) (c) All correspondence sent to an elector
 6 pursuant to this subsection (5) shall be maintained in the elector's
 7 registration records stored in the statewide voter registration system
 8 created in section 1-2-301; EXCEPT THAT ANY UNDELIVERABLE MESSAGE
 9 OR ANY OTHER MESSAGE INDICATING THAT THE ELECTOR'S
 10 ELECTRONIC-MAIL ADDRESS IS NO LONGER VALID AS DESCRIBED IN
 11 SUBSECTION (5)(a)(II) OF THIS SECTION DOES NOT NEED TO BE STORED IN
 12 THE STATEWIDE VOTER REGISTRATION SYSTEM.

13 **SECTION 2.** In Colorado Revised Statutes, 1-2-102, **amend**

1 (1)(a)(II) as follows:

2 **1-2-102. Rules for determining residence.** (1) The following
3 rules shall be used to determine the residence of a person intending to
4 register or to vote in any precinct in this state and shall be used by
5 election judges in challenge procedures:

6 (a) (II) ~~The mailing address of a homeless individual shall~~
7 ~~constitute that individual's residence for purposes of registering or voting~~
8 ~~in any precinct in this state. A homeless individual who has no mailing~~
9 ~~address shall not be eligible to register or to vote. The mailing address of~~
10 ~~a homeless individual may include a shelter, a homeless service provider,~~
11 ~~or a private residence, but it may not include a post office box or general~~
12 ~~delivery at a post office.~~ FOR THE PURPOSE OF VOTER REGISTRATION
13 RESIDENCE, A HOMELESS ELECTOR SHALL IDENTIFY A SPECIFIC LOCATION
14 WITHIN A COUNTY WHERE THE ELECTOR RETURNS TO REGULARLY. THIS
15 LOCATION MAY INCLUDE A HOMELESS SHELTER, A HOMELESS SERVICES
16 PROVIDER, A PARK, A CAMPGROUND, A VACANT LOT, A BUSINESS ADDRESS,
17 OR ANY OTHER PHYSICAL LOCATION. IF THE HOMELESS ELECTOR'S
18 REGISTRATION RESIDENCE DOES NOT INCLUDE A MAILING ADDRESS, THE
19 ELECTOR SHALL ALSO PROVIDE A MAILING ADDRESS.

20 **SECTION 3.** In Colorado Revised Statutes, 1-2-103, **amend** (1)
21 and (4) as follows:

22 **1-2-103. Military service - students - inmates - persons with**
23 **behavioral or mental health disorders - confinement.** (1) For the
24 purposes of registration, voting, and eligibility for office, no person shall
25 ~~gain~~ GAINS residence by reason of that person's presence, or ~~lose~~ LOSES it
26 by reason of absence, while in the civil or military service of the state or
27 of the United States; ~~nor~~ while a student at any institution of higher

1 education; ~~nor~~ OR while confined in a correctional facility, jail, or state
2 institution IF THE PERSON IS NOT SERVING A SENTENCE FOR A FELONY
3 CONVICTION.

4 (4) No person while serving a sentence of detention or
5 confinement in a correctional facility, jail, or other location for a felony
6 conviction or while serving a sentence of parole ~~shall be~~ IS eligible to
7 register to vote or to vote in any election; ~~however,~~ EXCEPT THAT a
8 confined prisoner who is awaiting trial but has not been tried OR WHO IS
9 NOT SERVING A SENTENCE FOR A FELONY CONVICTION shall be certified by
10 the institutional administrator, ~~and~~ shall be permitted to register to vote
11 ~~by mail registration pursuant to part 5 of this article~~ ARTICLE 2, AND MAY
12 LIST HIS OR HER CONFINEMENT LOCATION AS HIS OR HER BALLOT ADDRESS
13 IN ACCORDANCE WITH SECTION 1-2-204 (2)(f.3).

14 **SECTION 4.** In Colorado Revised Statutes, 1-2-204, **amend**
15 (2)(i); **repeal** (2)(k); and **add** (2)(f.3) as follows:

16 **1-2-204. Questions answered by elector - rules.** (2) In addition,
17 each elector shall correctly answer the following:

18 (f.3) THE ADDRESS WHERE THE ELECTOR WISHES TO RECEIVE HIS
19 OR HER BALLOT IF DIFFERENT FROM THE ADDRESS OF RECORD;

20 (i) Whether or not the elector ~~has voted or~~ was registered to vote
21 ~~in another county of this state or~~ in another state;

22 (k) ~~Whether any communication by mail from the county clerk~~
23 ~~and recorder to such eligible elector, including a confirmation card~~
24 ~~provided pursuant to section 1-2-605, should be sent to the elector's~~
25 ~~deliverable mailing address;~~

26 **SECTION 5.** In Colorado Revised Statutes, 1-2-213, **amend**
27 (2)(a) and (6) as follows:

1 **1-2-213. Registration at driver's license examination facilities.**

2 (2) (a) An applicant who wishes to complete an application for
3 registration must provide the information required by section 1-2-204 and
4 make the self-affirmation required under section 1-2-205 WITH THE
5 EXCEPTION OF THE INFORMATION REQUIRED BY SECTION 1-2-204 (2)(f.3).
6 THE APPLICANT SHALL ALSO SIGN THE SELF-AFFIRMATION REQUIRED BY
7 SECTION 1-2-205.

8 (6) (a) Unless the registrant states on the form that the change of
9 address is not for voter registration purposes, any eligible ANY
10 REGISTERED elector who informs a driver's license examination facility of
11 a change of name or address must have notice of the change of name or
12 address forwarded by the driver's license examination facility to the
13 county clerk and recorder of the county in which the elector resides.

14 (b) The county clerk and recorder of the county in which the
15 elector resides shall change the registration record of the elector to reflect
16 the change of name and address, MARK THE REGISTRATION RECORD AS
17 "ACTIVE", AND SEND TO THE ELECTOR'S ADDRESS OF RECORD, BY
18 FORWARDABLE MAIL, NOTICE OF THE CHANGE AND A POSTAGE PAID
19 PRE-ADDRESSED RETURN FORM BY WHICH THE ELECTOR MAY VERIFY OR
20 CORRECT THE INFORMATION.

21 (c) IF THE ELECTOR RETURNS THE FORM DESCRIBED IN SUBSECTION
22 (6)(b) OF THIS SECTION AND INDICATES THAT THE CHANGE WAS IN ERROR,
23 THE APPROPRIATE COUNTY CLERK AND RECORDER SHALL IMMEDIATELY
24 CORRECT THE ELECTOR'S PREVIOUSLY UPDATED INFORMATION IN THE
25 STATEWIDE VOTER REGISTRATION DATABASE.

26 **SECTION 6.** In Colorado Revised Statutes, 1-2-219, **amend** (1)
27 as follows:

1 **1-2-219. Changing or withdrawing declaration of affiliation.**

2 (1) Any eligible elector desiring to change or withdraw the elector's
3 affiliation may do so by completing and signing a prescribed request for
4 the change or withdrawal and filing it with the county clerk and recorder
5 or by submitting a personal letter written by the elector to the county clerk
6 and recorder at any time up to and including the twenty-ninth day
7 preceding ~~an~~ A PRIMARY election; except that, if the twenty-ninth day
8 before ~~an~~ THE PRIMARY election is a Saturday, Sunday, or legal holiday,
9 the change or withdrawal applies if made by the next day that is not a
10 Saturday, Sunday, or legal holiday. The prescribed form or personal letter
11 for the change must include the elector's printed name, address within the
12 county, birth date, social security number, if the elector wishes to state it,
13 and signature, the date, the elector's previous affiliation status, and the
14 requested change in affiliation status. A prescribed form must be
15 furnished by the county clerk and recorder upon the elector's oral or
16 written request. Upon receiving the request, the county clerk and recorder
17 shall change the elector's affiliation on his or her registration record. If
18 the affiliation is withdrawn, the designation on the elector's registration
19 record must be changed to "unaffiliated". If an elector changes affiliation,
20 the elector is entitled to vote, at any primary election, only the ballot of
21 the political party to which the elector is currently affiliated. A change or
22 withdrawal of affiliation may not be made by anyone other than the
23 elector. NOTWITHSTANDING ANY OTHER PROVISION OF LAW, A
24 DECLARATION OR CHANGE OF AFFILIATION MADE BY AN UNAFFILIATED
25 ELECTOR IN ACCORDANCE WITH THIS SECTION MUST BE DEFERRED IF THE
26 ELECTOR HAS ALREADY BEEN MAILED A PRIMARY ELECTION BALLOT
27 PACKET. THE DEADLINE BY WHICH THE ELECTOR MUST DECLARE, CHANGE,

1 OR WITHDRAW AN AFFILIATION AS SPECIFIED IN THIS SUBSECTION (1) ONLY
2 APPLIES TO A PRIMARY ELECTION AND DOES NOT APPLY TO A GENERAL OR
3 COORDINATED ELECTION.

4 **SECTION 7.** In Colorado Revised Statutes, 1-2-302, **amend** (6)
5 as follows:

6 **1-2-302. Maintenance of computerized statewide voter**
7 **registration list - confidentiality.** (6) The secretary of state shall
8 determine and use other necessary means to maintain the master list of
9 registered electors on a current basis. The department of state and the
10 department of revenue shall allow for the exchange of information
11 between the systems used by them to collect information on residence
12 addresses, signatures, and party affiliation for all applicants for driver's
13 licenses or state identification cards. NO LATER THAN JULY 31, 2019, THE
14 DEPARTMENT OF STATE SHALL REGULARLY PROVIDE THE DEPARTMENT OF
15 REVENUE WITH CURRENT VOTER REGISTRATION INFORMATION. THE
16 DEPARTMENT OF REVENUE MUST USE THE INFORMATION TO DETERMINE
17 WHETHER AN INDIVIDUAL IS REGISTERED TO VOTE AT THE TIME HE OR SHE
18 APPLIES TO OBTAIN, RENEW, OR UPDATE A DRIVER'S LICENSE OR STATE
19 IDENTIFICATION CARD. THE DEPARTMENT OF STATE SHALL REIMBURSE THE
20 DEPARTMENT OF REVENUE, THROUGH A ONE-TIME REIMBURSEMENT, FOR
21 ANY INITIAL COSTS THE DEPARTMENT OF REVENUE INCURS IN CONNECTION
22 WITH UPDATING COLORADO DRIVES, AS DEFINED IN SECTION 42-1-102
23 (16.5), TO ALLOW THE DEPARTMENT OF REVENUE TO RECEIVE VOTER
24 REGISTRATION INFORMATION AND TO USE SUCH INFORMATION FOR THE
25 PURPOSES DESCRIBED IN THIS SECTION. The department of revenue may
26 exchange information on residence addresses in the driver's license
27 database with the motor vehicle registration database, motorist insurance

1 database, and the state income tax information systems.

2 **SECTION 8.** In Colorado Revised Statutes, 1-3-101, **amend** (1),
3 (2), and (3)(a) as follows:

4 **1-3-101. Party affiliation required - residence.** (1) In order to
5 vote at any precinct caucus, assembly, or convention of a political party,
6 the elector must be a resident of the precinct for ~~thirty~~ TWENTY-TWO days,
7 must be registered to vote no later than ~~twenty-nine~~ TWENTY-TWO days
8 before the caucus, assembly, or convention, and must be affiliated with
9 the political party holding the caucus, assembly, or convention for at least
10 ~~two months~~ TWENTY-TWO DAYS as shown in the statewide voter
11 registration system; except that any registered elector who has attained the
12 age of eighteen years or who has become a naturalized citizen during the
13 ~~two months~~ TWENTY-TWO DAYS immediately preceding the meeting may
14 vote at any caucus, assembly, or convention even though the elector has
15 been affiliated with the political party for less than ~~two months~~
16 TWENTY-TWO DAYS.

17 (2) Notwithstanding subsection (1) of this section and section
18 1-2-101 (1)(b), an elector who moves from the precinct where registered
19 during the ~~twenty-nine~~ TWENTY-ONE days prior to any caucus ~~shall be~~
20 ~~permitted to~~ MAY participate IN and vote at the caucus in the precinct of
21 the elector's former residence but shall not be eligible for election as a
22 delegate or for nomination as a precinct committeeperson in the former
23 precinct.

24 (3) (a) No later than ~~twenty-eight~~ TWENTY-ONE days prior to the
25 date of the precinct caucus, the county clerk and recorder shall furnish
26 without charge to each major political party in the county a list of the
27 registered electors in the county who are affiliated with that political

1 party.

2 **SECTION 9.** In Colorado Revised Statutes, 1-3-103, **amend**
3 (9)(a) as follows:

4 **1-3-103. Party committees.** (9) (a) No later than ninety days
5 after the organization of the state central committees of the major political
6 parties in each odd-numbered year, each committee shall adopt in its
7 bylaws or rules its general guidelines and regulations for all county party
8 matters. Such bylaws or rules shall establish a procedure for the selection
9 of delegates to any party assembly that is consistent with party practice.
10 Any method under such procedure for choosing or allocating delegates in
11 a county based on the number of votes cast at an election for a particular
12 candidate shall be uniform among the counties so that all types of ballots
13 are counted or not counted for purposes of determining the number of
14 votes cast. Any county central committee may adopt its own rules in
15 conformance with those of the state central committee. In the absence of
16 county rules pertaining to specific items, the party's state central
17 committee's guidelines and rules shall apply. Each state central committee
18 shall file its party's bylaws or rules with the secretary of state no later than
19 the first Monday in February in each even-numbered year and, if filed
20 prior to that date, the bylaws or rules may be amended until that date. No
21 bylaw or rule may be filed or amended after the first Monday in February
22 in each even-numbered year. Where the bylaws or rules are not filed in
23 accordance with this section, the party's state central committee, as well
24 as the party's county central committee, are subject to the code through
25 the general election of the same year. EACH STATE CENTRAL COMMITTEE
26 SHALL COMPILE AND PROVIDE TO THE SECRETARY OF STATE INFORMATION
27 CONCERNING THE MEMBERSHIP OF THE COUNTY CENTRAL COMMITTEES OF

1 THE PARTY IN ADDITION TO THE BYLAWS OR RULES OF EACH COUNTY
2 CENTRAL COMMITTEE.

3 **SECTION 10.** In Colorado Revised Statutes, 1-4-801, **amend**
4 (2)(a) as follows:

5 **1-4-801. Designation of party candidates by petition.** (2) The
6 signature requirements for the petition are as follows:

7 (a) Every petition in the case of a candidate for any county office
8 ~~shall~~ MUST be signed by electors eligible to vote within the county
9 commissioner district or political subdivision for which the officer is to
10 be elected. Except as otherwise provided in ~~paragraph (e) of this~~
11 ~~subsection (2)~~ SUBSECTION (2)(e) OF THIS SECTION, the petition ~~shall~~ MUST
12 require signers equal in number to twenty percent of the votes cast in the
13 political subdivision at the contested or uncontested primary election for
14 the political party's candidate for the office for which the petition is being
15 circulated or, if there was no primary election, at the last preceding
16 general election for which there was a candidate for the office.
17 NOTWITHSTANDING ANY OTHER PROVISION OF LAW, AN UNAFFILIATED
18 ELECTOR IS NOT ELIGIBLE TO SIGN A PETITION FOR A CANDIDATE OF A
19 MAJOR POLITICAL PARTY.

20 **SECTION 11.** In Colorado Revised Statutes, **amend** 1-4-1103 as
21 follows:

22 **1-4-1103. Write-in votes for governor, president.** (1) No
23 write-in vote for governor in a general election ~~shall~~ WILL be counted
24 unless it includes a write-in vote for lieutenant governor.

25 (2) NO WRITE-IN VOTE FOR PRESIDENT IN A GENERAL ELECTION
26 WILL BE COUNTED UNLESS IT INCLUDES A WRITE-IN VOTE FOR
27 VICE-PRESIDENT.

1 **SECTION 12.** In Colorado Revised Statutes, 1-5-208, **amend** (6)
2 as follows:

3 **1-5-208. Election may be canceled - when.** (6) The governing
4 body shall provide notice by publication of the cancellation of the
5 election. A copy of the notice must be posted ~~at each voter service and~~
6 ~~polling center of the political subdivision,~~ in the office of the designated
7 election official and in the office of the clerk and recorder for each county
8 in which the political subdivision is located and, for special districts, a
9 copy of the notice must be filed in the office of the division of local
10 government. The governing body shall also notify the candidates that the
11 election was canceled and that they were elected by acclamation.

12 **SECTION 13.** In Colorado Revised Statutes, 1-5-402, **repeal** (2)
13 as follows:

14 **1-5-402. Primary election ballots.** (2) ~~No later than forty-five~~
15 ~~days before the primary election, the county clerk and recorder shall~~
16 ~~prepare a combined primary election ballot to be used by unaffiliated~~
17 ~~electors. the ballot must be printed in the following manner:~~

27 1-10.5-102, the county clerk and recorder shall order a recount of the

1 votes cast for the office, ballot question, or ballot issue. Any recount of
2 the votes shall be completed no later than the ~~thirtieth~~ THIRTY-FIFTH day
3 after the election. A political subdivision that referred a ballot issue or
4 ballot question to the electors may waive the automatic recount provisions
5 of this section if the ballot issue or ballot question fails by giving written
6 notice to the county clerk and recorder within ~~fourteen days after the~~
7 ~~primary election or eighteen~~ TWENTY-THREE days after any ~~other~~ election.

8 **SECTION 38.** In Colorado Revised Statutes, 1-10.5-106, **amend**
9 (2) as follows:

10 **1-10.5-106. Request for recount by interested party -**
11 **definitions.** (2) Whenever a recount is not required, an interested party
12 may submit a notarized written request for a recount at the expense of the
13 interested party making the request. This request shall be filed with the
14 secretary of state, the county clerk and recorder, the designated election
15 official, or other governing body that originally certified the candidate,
16 ballot question, or ballot issue for the ballot within ~~twenty-one days after~~
17 ~~a primary election and within thirty-one~~ TWENTY-EIGHT days after any
18 ~~other~~ PRIMARY, GENERAL, OR COORDINATED election. Such election
19 official shall notify the political subdivision within which the election was
20 held no later than the day following receipt of the request. Before
21 conducting the recount, the election official who will conduct the recount
22 shall determine the cost of the recount within one day of receiving the
23 request to recount, notify the interested party that requested the recount of
24 the cost, and collect the costs of conducting the recount. If the request is
25 filed with the secretary of state, the secretary of state shall determine the
26 cost of the recount by adding the individual amounts determined by the
27 political subdivisions conducting the recount. The interested party that

1 requested the recount shall pay the cost of the recount by certified funds
2 to the election official with whom the request for a recount was filed
3 within one day of receiving the election official's cost determination. The
4 funds shall be placed in escrow for payment of all expenses incurred in the
5 recount. If after the recount the result of the election is reversed in favor
6 of the interested party that requested the recount or if the amended
7 election count is such that a recount otherwise would have been required,
8 the payment for expenses shall be refunded to the interested party that
9 requested the recount. Any escrow amounts not refunded to the interested
10 party that requested the recount shall be paid to the election officials who
11 conducted the recount. Any recount of votes pursuant to this section shall
12 be completed no later than the ~~thirtieth day after the primary election and~~
13 ~~no later than the~~ thirty-seventh day after any ~~other~~ PRIMARY, GENERAL, OR
14 COORDINATED election.

15 **SECTION 39.** In Colorado Revised Statutes, **amend** 1-12-105 as
16 follows:

17 **1-12-105. Signatures required for school district officers.** A
18 petition to recall a school district officer shall be signed by eligible
19 electors of the school district equal in number to at least forty percent of
20 ~~those electors who voted in such district in the last preceding election at~~
21 ~~which the director to be recalled was elected as indicated by the pollbook~~
22 ~~or abstract for such election~~ THE ENTIRE VOTE CAST AT THE LAST
23 PRECEDING ELECTION FOR ALL CANDIDATES FOR THE SCHOOL DISTRICT
24 DIRECTOR POSITION OCCUPIED BY THE INCUMBENT SOUGHT TO BE
25 RECALLED. If no such election was held, the petition shall be signed by
26 eligible electors of the school district equal in number to at least ten
27 percent of those electors residing within the school district on the date that

1 the petition is approved as to form under section 1-12-108 (4). In no case
2 shall the number required for recall be less than ten percent of eligible
3 electors qualified to vote in the most recent biennial school election;
4 except that no more than fifteen thousand signatures is required.

5 **SECTION 40.** In Colorado Revised Statutes, 1-12-108, **amend**
6 (9)(d) as follows:

7 **1-12-108. Petition requirements - approval as to form -**
8 **determination of sufficiency - protest - offenses.** (9) (d) (I) NOT LATER
9 THAN THREE DAYS AFTER THE PETITION HAS BEEN FILED IN ACCORDANCE
10 WITH SUBSECTION (7.5) OF THIS SECTION, any signer may request that his
11 or her name be stricken from the petition ~~at any time prior to when the~~
12 ~~petition is deemed sufficient and the time for protest has passed~~ by filing
13 with the designated election official a written request that his or her
14 signature be stricken and delivering a copy of the request to at least one
15 member of the committee. If the request is delivered to the member of the
16 committee or the designated election official through the United States
17 mail, it shall be deemed delivered to the committee or the designated
18 election official on the date shown by the cancellation mark on the
19 envelope containing the request received by the member of the committee
20 or the designated election official. If the request is delivered to the
21 member of the committee or the designated election official in any other
22 manner, it shall be deemed delivered to the committee or the designated
23 election official on the date of delivery and stamped receipt by the
24 designated election official.

25 (II) If the designated election official receives a written request
26 TIMELY filed in accordance with ~~this paragraph (d) after the petition is~~
27 ~~filed but before the petition is deemed sufficient and the time for protest~~

1 ~~has passed~~ SUBSECTION (9)(d)(I) OF THIS SECTION, the election official
2 shall strike the signature of the signer who filed the request. If the election
3 official receives such a written request before the petition is filed, the
4 election official shall strike the signature of the signer who filed the
5 request promptly upon the filing of the petition.

6 **SECTION 41.** In Colorado Revised Statutes, 1-1-104, **amend**
7 **(2.8)(a)** as follows:

8 **1-1-104. Definitions.** As used in this code, unless the context
9 **otherwise requires:**

10 **(2.8) "Confirmation card" means a communication mailed from a**
11 **county clerk and recorder to an elector pursuant to section 1-2-302.5**
12 **(2)(b)(III), 1-2-509 (3)(b)(III), or 1-2-605, which card must:**

13 **(a) Be mailed to the elector's address of record; unless the elector**
14 **has requested that such communication be sent to his or her deliverable**
15 **mailing address pursuant to section 1-2-204 (2)(k);**

16 **SECTION 42.** In Colorado Revised Statutes, 1-7-201, **amend**
17 **(2.3)** as follows:

18 **1-7-201. Voting at primary election. (2.3)** An eligible
19 **unaffiliated elector is entitled to vote in the primary election of a major**
20 **political party without affiliating with that political party. To vote in a**
21 **political party's primary election without declaring an affiliation with the**
22 **political party, any eligible unaffiliated elector shall be given a combined**
23 **ballot, if applicable. If a combined ballot is not available, the elector shall**
24 **declare to the election judges the name of the political party in whose**
25 **primary election the elector wishes to vote. Thereupon, the election judges**
26 **shall deliver the appropriate party ballot to the elector. In addition, any**
27 **eligible unaffiliated elector may openly declare to the election judges the**

1 name of the political party with which the elector wishes to affiliate and
2 complete the necessary forms. An eligible elector must separately date and
3 sign or date and initial a declaration of affiliation with a political party
4 form in such manner that the elector clearly acknowledges that the
5 affiliation has been properly recorded. Thereupon, the election judges
6 shall deliver the appropriate party ballot to the eligible elector.

7 **SECTION 43. Appropriation.** (1) For the 2018-19 state fiscal
8 year, \$63,000 is appropriated to the department of state for use by the
9 elections division. This appropriation is from the department of state cash
10 fund created in section 24-21-104 (3)(b), C.R.S. To implement this act, the
11 division may use this appropriation for operating costs.

12 (2) For the 2018-19 state fiscal year, \$63,000 is appropriated to the
13 department of revenue. This appropriation is from reappropriated funds
14 received from the department of state under subsection (1) of this section.
15 To implement this act, the department may use this appropriation for
16 operating expenses related to DMV IT System (DRIVES) Support.

17 **SECTION 44. Effective date - applicability.** (1) This act takes
18 effect upon passage; except that section 26 of this act takes effect July 1,
19 2018.

20 (2) This act applies to elections conducted on or after the
21 applicable effective date of this act.

22 **SECTION 45. Safety clause.** The general assembly hereby finds,
23 determines, and declares that this act is necessary for the immediate
24 preservation of the public peace, health, and safety.
