CONCERNING FUNDING FOR PERMANENT PART-TIME LEGISLATIVE AIDES FOR MEMBERS OF THE GENERAL ASSEMBLY TO ALLOW AIDES TO BE ELIGIBLE TO ENROLL IN STATE HEALTH BENEFIT PLANS PURSUANT TO A POLICY ADOPTED BY THE EXECUTIVE COMMITTEE OF THE GENERAL ASSEMBLY.

*Be it enacted by the General Assembly of the State of Colorado:*

**SECTION 1.** In Senate Bill 21-196, **amend** section 1 (1) introductory portion and (1)(a) as follows:

Section 1. **Appropriation.** (1) For the 2021-22 state fiscal year,

~~\$54,276,399~~ \$54,893,747 is appropriated to the legislative department. This appropriation consists of ~~\$53,005,160~~ \$53,622,508 from the general fund, \$90,000 from cash funds, and \$1,181,239 from reappropriated funds. The legislative department may use this appropriation as follows:

(a) ~~\$18,206,852~~ \$18,824,200 for use by the general assembly, which amount:

(I) Consists of ~~\$18,116,852~~ \$18,734,200 from the general fund and \$90,000 from cash funds generated from the sale of bill boxes, legislative directories, and publications and other services provided by the print shop; and

(II) Is based on the assumption that the general assembly will have ~~74.4~~ 144.4 FTE;

**SECTION 2. Effective date.** This act takes effect upon passage only if Senate Bill 21-196 becomes law and takes effect either upon the effective date of this act or Senate Bill 21-196, whichever is later.

**SECTION 3. Safety clause.** The general assembly hereby finds,

determines, and declares that this act is necessary for the immediate preservation of the public peace, health, or safety.
