**A BILL FOR AN ACT**

101 **CONCERNING THE COLLECTION OF CHARITABLE SOLICITATIONS FROM**  
102 **PASSING MOTORISTS ON A PUBLIC ROADWAY BY LOCAL**  
103 **GOVERNMENT PUBLIC SAFETY PERSONNEL.**

**Bill Summary**

The bill specifies that local public safety personnel may solicit charitable contributions from motorists in public roadways if the charitable organization has filed an application with the governing body of the local government having jurisdiction over the location where the

solicitation is to occur. A local government may not deny an application that meets the minimum criteria established in the bill, but may place reasonable restrictions on the solicitation.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** Article 5 of title 29, Colorado Revised Statutes, is  
3 amended BY THE ADDITION OF A NEW PART to read:

4 **PART 2**

5 **PUBLIC SAFETY CHARITABLE SOLICITATION**

6 **29-5-201. Short title.** THIS PART 2 SHALL BE KNOWN AND MAY BE  
7 CITED AS THE "PUBLIC SAFETY CHARITABLE SOLICITATION ACT".

8 **29-5-202. Legislative declaration.** (1) THE GENERAL ASSEMBLY  
9 HEREBY FINDS AND DECLARES THAT:

10 (a) FOR OVER FIFTY YEARS, FIREFIGHTERS ACROSS COLORADO  
11 HAVE ENGAGED IN CHARITABLE FUNDRAISING EVENTS TO:

12 (I) SUPPORT MEDICAL RESEARCH OF DEBILITATING DISEASES SUCH  
13 AS MUSCULAR DYSTROPHY;

14 (II) PROVIDE COMPREHENSIVE HEALTH CARE AND SUPPORT  
15 SERVICES, ADVOCACY, AND EDUCATION ON BEHALF OF CHILDREN AND  
16 ADULTS WITH NEUROMUSCULAR DISEASES; AND

17 (III) CONDUCT SUMMER CAMPS FOR CHILDREN WITH MUSCULAR  
18 DYSTROPHY.

19 (b) THE MOST SUCCESSFUL FUNDRAISING EVENT THAT  
20 FIREFIGHTERS HAVE EMPLOYED IS THE SIGNATURE "FILL THE BOOT"  
21 CAMPAIGN, WHICH CONSISTS OF FIREFIGHTERS ASKING MOTORISTS PASSING  
22 FIRE STATIONS TO CONTRIBUTE TO THE CAUSES SPECIFIED IN PARAGRAPH  
23 (a) OF THIS SUBSECTION (1) BY PUTTING MONEY INTO THE FIREFIGHTER  
24 BOOTS OR FACSIMILES OF FIREFIGHTER BOOTS.

1 (c) BECAUSE SOME LOCAL ORDINANCES LIMIT OR PROHIBIT  
2 AGGRESSIVE BEGGING OR PANHANDLING IN PUBLIC ROADWAYS,  
3 FIREFIGHTERS ORGANIZING AND CONDUCTING "FILL THE BOOT"  
4 CAMPAIGNS HAVE EXPERIENCED A DECLINE IN CONTRIBUTIONS.

5 (d) FIREFIGHTERS IN COLORADO, ALONG WITH LAW ENFORCEMENT  
6 ORGANIZATIONS THAT CONDUCT SIMILAR FUNDRAISING ACTIVITIES, ARE  
7 CONCERNED THAT ACTIVITIES INVOLVING COLLECTIONS FROM PASSING  
8 MOTORISTS WERE UNINTENTIONALLY CATEGORIZED AS PROHIBITED  
9 ACTIVITIES.

10 (e) THE COMPELLING INTEREST IN OFFERING THE EXPRESS PROCESS  
11 CONTAINED IN THIS PART 2 TO LAW ENFORCEMENT PERSONNEL,  
12 FIREFIGHTERS, AND OTHER PUBLIC SAFETY PERSONNEL DOES NOT IMPINGE  
13 UPON, AND ESSENTIALLY FURTHERS THE STATED INTERESTS OF, THE  
14 RELEVANT LOCAL ORDINANCES BY NARROWLY TAILORING THE PROCESS  
15 AUTHORIZED BY THIS PART 2 TO THOSE LOCAL GOVERNMENT PERSONNEL  
16 MOST SUITED TO PROTECT THE PUBLIC SAFETY.

17 (f) THE EXTRAORDINARY LIABILITY INSURANCE REQUIRED BY THIS  
18 PART 2 IS NECESSARY TO PROTECT THE PUBLIC SAFETY AND IS DUE SOLELY  
19 TO THE PARTICULAR AND UNIQUE CIRCUMSTANCES INVOLVING THE  
20 COLLECTION OF CHARITABLE SOLICITATIONS FROM PASSING MOTORISTS IN  
21 A PUBLIC ROADWAY.

22 (2) THEREFORE, IT IS THE INTENT OF THE GENERAL ASSEMBLY IN  
23 ENACTING THIS PART 2 TO CLARIFY THAT LAW ENFORCEMENT PERSONNEL  
24 AND FIREFIGHTERS AS WELL AS OTHER LOCAL SAFETY PERSONNEL,  
25 BECAUSE OF THEIR ESTABLISHED TRAINING AND EXPERIENCE IN  
26 CONTROLLING TRAFFIC AND OTHER ACTIVITIES IN AND AROUND PUBLIC  
27 ROADWAYS, MAY BE PROVIDED A SEPARATE PROCEDURE FOR OBTAINING

1 PERMITS FROM LOCAL GOVERNMENTS TO CONDUCT FUNDRAISING  
2 ACTIVITIES SUCH AS "FILL THE BOOT" CAMPAIGNS, NOTWITHSTANDING  
3 ANY CITY OR COUNTY ORDINANCE GOVERNING SOLICITATIONS FOR  
4 CHARITABLE CONTRIBUTIONS ON PUBLIC ROADWAYS.

5 **29-5-203. Definitions.** AS USED IN THIS PART 2, UNLESS THE  
6 CONTEXT OTHERWISE REQUIRES:

7 (1) "CHARITABLE ORGANIZATION" SHALL HAVE THE SAME  
8 MEANING AS SET FORTH IN SECTION 6-16-103 (1), C.R.S.

9 (2) "CHARITABLE PURPOSE" SHALL HAVE THE SAME MEANING AS  
10 SET FORTH IN SECTION 6-16-103 (2), C.R.S.

11 (3) "LOCAL GOVERNMENT" MEANS ANY COUNTY, TOWN, CITY, CITY  
12 AND COUNTY, MUNICIPALITY, OR OTHER LOCAL ENTITY HAVING THE  
13 AUTHORITY TO ENACT LOCAL ORDINANCES.

14 **29-5-204. Local government authorization for solicitation of**  
15 **charitable donations.** (1) A CHARITABLE ORGANIZATION MAY ENGAGE  
16 IN A SOLICITATION FOR CHARITABLE PURPOSES THAT INVOLVES PERSONS  
17 STANDING IN OR ADJACENT TO A PUBLIC ROADWAY AND WHO SOLICIT  
18 DONATIONS FROM MOTORISTS IF:

19 (a) THE PERSONS ARE:

20 (I) LAW ENFORCEMENT PERSONNEL, FIREFIGHTERS, OR PERSONS  
21 WHO OTHERWISE VOLUNTEER FOR OR ARE EMPLOYED BY A LOCAL  
22 GOVERNMENT TO PROTECT THE PUBLIC SAFETY; AND

23 (II) SOLICITING IN AN AREA THAT IS ENTIRELY WITHIN THE  
24 JURISDICTION OF THE LOCAL GOVERNMENT; AND

25 (b) THE CHARITABLE ORGANIZATION FILES AN APPLICATION WITH  
26 THE GOVERNING BODY OF THE LOCAL GOVERNMENT HAVING JURISDICTION  
27 OVER THE LOCATIONS OF THE SOLICITATION. SUCH APPLICATION SHALL BE

1 FILED NO LATER THAN THIRTY BUSINESS DAYS PRIOR TO THE DATE THAT  
2 THE SOLICITATION BEGINS AND SHALL INCLUDE, BUT NOT BE LIMITED TO,  
3 THE FOLLOWING:

4 (I) THE DATE AND TIME OF THE SOLICITATION;

5 (II) THE LOCATION OF THE SOLICITATION;

6 (III) A DESCRIPTION OF THE MANNER AND CONDITIONS UNDER  
7 WHICH THE SOLICITATION IS TO OCCUR; AND

8 (IV) A CERTIFICATE OF INSURANCE OR OTHER PROOF OF A VALID  
9 LIABILITY INSURANCE POLICY IN THE AMOUNT OF ONE MILLION DOLLARS  
10 INSURING THE CHARITABLE ORGANIZATION, THE LAW ENFORCEMENT  
11 PERSONNEL, FIREFIGHTERS, OR OTHER PERSONS CONDUCTING THE  
12 SOLICITATION, AND THE LOCAL GOVERNMENT HAVING JURISDICTION.

13 (2) WITHIN TWENTY-FIVE BUSINESS DAYS OF THE RECEIPT OF THE  
14 APPLICATION, THE GOVERNING BODY OF THE LOCAL GOVERNMENT HAVING  
15 JURISDICTION OVER THE LOCATIONS WHERE THE SOLICITATION IS TO  
16 OCCUR SHALL APPROVE OR DENY THE APPLICATION. AN APPLICATION  
17 THAT MEETS THE CRITERIA CONTAINED IN PARAGRAPH (b) OF SUBSECTION  
18 (1) OF THIS SECTION SHALL NOT BE REJECTED, BUT THE GOVERNING BOARD  
19 MAY, IN WRITING, IMPOSE REASONABLE CONDITIONS THAT ARE  
20 CONSISTENT WITH THE INTENT OF THIS PART 2 AND THAT ARE BASED ON  
21 ARTICULATED PUBLIC SAFETY CONCERNS.

22 (3) NOTHING IN THIS PART 2 SHALL BE CONSTRUED TO PREVENT A  
23 LOCAL GOVERNMENT FROM ENACTING REASONABLE TIME, PLACE, OR  
24 MANNER RESTRICTIONS ON THE CHARITABLE SOLICITATION IN A PUBLIC  
25 ROADWAY BY PERSONS OR CHARITIES NOT DESCRIBED IN THIS PART 2.

26 **SECTION 2. Act subject to petition - effective date.** This act  
27 shall take effect at 12:01 a.m. on the day following the expiration of the

1 ninety-day period after final adjournment of the general assembly (August  
2 10, 2011, if adjournment sine die is on May 11, 2011); except that, if a  
3 referendum petition is filed pursuant to section 1 (3) of article V of the  
4 state constitution against this act or an item, section, or part of this act  
5 within such period, then the act, item, section, or part shall not take effect  
6 unless approved by the people at the general election to be held in  
7 November 2012 and shall take effect on the date of the official  
8 declaration of the vote thereon by the governor.
