33 *The Secretary of the Senate and the Chief Clerk of the House of
34 Representatives are authorized to hire Legislative Aides pursuant to Joint
35 Rule 39 of the House of Representatives and the Senate. If Legislative
36 Aides are authorized by the Executive Committee, acting in accordance
37 with such Joint Rule 39, to start prior to the convening of the next regular
38 session, they may be paid at the rate specified in this resolution from the

1 date they are authorized to start.

2 (2) That the Secretary of the Senate and the Chief Clerk of the House
3 of Representatives remain in such capacity after adjournment of the
4 General Assembly *sine die* until the convening of the Second Regular
5 Session of the Seventy-second General Assembly in January, 2020.

6 (3) That the Chair of the Senate Services Committee, with the
7 authorization of the President of the Senate, and the Chair of the House
8 Services Committee, with the authorization of the Speaker of the House
9 of Representatives, are hereby separately authorized to retain and hire
10 replacements for such employees for such period of time in the interim
11 between the First Regular Session of the Seventy-second General
12 Assembly and the Second Regular Session of the Seventy-second General
13 Assembly as they deem necessary for their respective houses; except that
14 the office equipment of the General Assembly and the services of such
15 employees shall be used only in connection with official legislative
16 business.

17 (4) That the Chair of the Senate Services Committee, with the
18 authorization of the President of the Senate, and the Chair of the House
19 Services Committee, with the authorization of the Speaker of the House
20 of Representatives, are hereby separately authorized to hire such
21 session-only employees for the next regular session as they deem
22 necessary for their respective houses and who may start their employment
23 on the date authorized.

24 (5) That the officers and the employees referred to in subsections (2)
25 through (4) of this resolution shall be compensated for their services at
26 the rate specified for such positions during the First Regular Session of
27 this Seventy-second General Assembly, as may be modified by any salary
28 survey adjustments and merit increases to become effective during the
29 fiscal year beginning July 1, 2019, which are approved by the President
30 of the Senate for officers and employees of the Senate and the Speaker of
31 the House of Representatives for officers and employees of the House of
32 Representatives. All such compensation shall be paid from money
33 appropriated for such purposes by the Seventy-second General Assembly.
