SENATE JOINT RESOLUTION 20-004

101 **CONCERNING PARKING ON THE GROUNDS OF THE STATE CAPITOL.**

1 *Be It Resolved by the Senate of the Seventy-second General*
2 *Assembly of the State of Colorado, the House of Representatives*
3 *concurring herein:*

4 (1) That, pursuant to sections 2-2-321, 24-82-101, and 24-82-103,
5 Colorado Revised Statutes, the Department of Personnel is responsible
6 for the maintenance of the State Capitol grounds and parking areas,
7 including paving, striping, signage, and snow removal, as well as the
8 provision of parking permits or tags and remote controls.

9 (2) That, pursuant to sections 2-2-321, 24-82-101, and 24-82-103,
10 Colorado Revised Statutes, responsibility for parking spaces in the State
11 Capitol circle is allocated as follows:

12 (a) The Governor is allocated twenty-six spaces to assign for use

1 by officials and staff of the Governor and Lieutenant Governor;

2 (b) The Colorado State Patrol is allocated five spaces; and

3 (c) The Speaker of the House of Representatives and the President
4 of the Senate are allocated one hundred thirty spaces to assign for use by
5 legislators and legislative staff.

6 (3) That, pursuant to sections 24-82-101 and 24-82-103, Colorado
7 Revised Statutes, the Department of Personnel shall adopt and enforce
8 regulations governing parking in all lots and facilities in the Capitol
9 Complex, including the State Capitol circle.

10 (4) That both entrances to the State Capitol circle shall remain
11 closed year-round; except that:

12 (a) The Colorado State Patrol may temporarily open the entrances
13 during special events and shall notify the Chief Clerk of the House of
14 Representatives and the Secretary of the Senate when the entrances are
15 open during normal business hours;

16 (b) Both the north and south entrances are accessible by electronic
17 remote control to persons who are assigned parking spaces in the State
18 Capitol circle; and

19 (c) The Speaker of the House of Representatives and the President
20 of the Senate may open the south entrance if they determine jointly that
21 the vehicle traffic does not pose a risk to the safety of pedestrians in the
22 State Capitol circle.

23 (5) Parking is permitted only in the State Capitol circle in a
24 designated parking space and there shall not be any parking on the
25 sidewalks on the grounds of the State Capitol; except that one marked
26 Colorado State Patrol vehicle and one official Colorado State Patrol
27 vehicle may park on the sidewalk adjacent to East Fourteenth Avenue as
28 long as those vehicles are not parked in a manner that blocks reasonable
29 access to the sidewalks for pedestrians, including persons with
30 disabilities.
