3	winning season with a 12-4 record, winning their fifth consecutive American Football Conference (AFC) Western Division Championship,
4	becoming the number one seed in the AFC, and sending the Pittsburgh
5	Steelers home for six months of needed rest and healing; and
6	WHEREAS, The Denver Broncos, on January 24, will face the
7	New England Patriots to compete for AND CLAIM the AFC
8	Championship and thereby head to Super Bowl 50 on Sunday, February
