SENATE JOINT RESOLUTION 21-005

101 **CONCERNING THE RECOGNITION OF LATINO ADVOCACY DAY.**

1 WHEREAS, Latino/a Advocacy Day (LAD) celebrates 15 years
2 of engaging Latinos from all over Colorado to use their voices to enact
3 change in state policy. LAD's legacy has enabled Latinos in Colorado to
4 take ownership of their political power and to build momentum in
5 advocacy and the policymaking process; and

6 WHEREAS, Latinos are a key part of Colorado's constituency.
7 Latinos are leaders in their families and communities, as well as in
8 elected offices throughout the country. The recent elections were historic
9 in electing Latinos to positions of power in our federal, state, and local
10 governments and in voter turnout among Latinos; and

11 WHEREAS, Engaging Latinos in the political process ensures that
12 the voices and lived experiences of all Coloradans are reflected in future
