**SENATE JOINT RESOLUTION 17-016**

101      **CONCERNING THE INSTALLATION OF A SCULPTURE AND EXPLANATORY**  
102                    **PLAQUE TO MEMORIALIZE THE VICTIMS OF THE SAND CREEK**  
103                    **MASSACRE OF NOVEMBER 29, 1864, ON THE STATE CAPITOL**  
104                    **GROUNDS.**

1                    WHEREAS, The State Capitol and its grounds contain memorials  
2                    to the state's political past as well as memorabilia promoting the state's  
3                    natural environment and history of events, individuals, and ethnic groups;  
4                    and

5                    WHEREAS, From time to time, proposals for gifts of art and  
6                    memorials are made to the state to be placed in the State Capitol or on its  
7                    grounds; and

8                    WHEREAS, Section 24-82-108 (3)(h), Colorado Revised Statutes,

1 requires the State Capitol Building Advisory Committee to establish  
2 criteria and a procedure for the evaluation of proposals for gifts of  
3 memorials for placement in the State Capitol or on its grounds; and

4 WHEREAS, The State Capitol Building Advisory Committee's  
5 evaluation criteria for a memorial is based partly upon the association the  
6 proposed memorial has with a significant event in the state's history, the  
7 connection of the memorial with persons significant in the heritage of the  
8 state, and its appropriateness to the designated area of the State Capitol;  
9 and

10 WHEREAS, The procedure stipulates that, if the Capital  
11 Development Committee and the Governor concur with the State Capitol  
12 Building Advisory Committee's recommendations regarding the  
13 placement of memorials on the State Capitol grounds, the Capital  
14 Development Committee may make its recommendation for acceptance  
15 of the donated art to the General Assembly in the form of a joint  
16 resolution introduced during an annual legislative session; and

17 WHEREAS, The State Capitol Building Advisory Committee, the  
18 Capital Development Committee, and the Governor have approved a plan  
19 for placement of a bronze sculpture and an accompanying explanatory  
20 plaque on the State Capitol grounds, the boundaries of which are  
21 described in section 24-82-108 (3)(a), Colorado Revised Statutes, subject  
22 to the State Capitol Building Advisory Committee approving the final  
23 design and the specific location; and

24 WHEREAS, The proposed language for the explanatory plaque  
25 reads as follows: "At daybreak, November 29, 1864, Colorado US  
26 Volunteers attacked a Cheyenne and Arapaho village at Sand Creek in  
27 southeastern Colorado Territory that had been guaranteed safety and  
28 protection by the US Army. Cheyenne chief Black Kettle flew an  
29 American flag and a white flag of truce over his lodge - yet the 675  
30 troops, supported by four howitzers, swept the village killing 230  
31 Cheyenne and Arapaho - mostly women, children, babies, and the elderly  
32 and wounding another 200. But for the courageous action of two veteran  
33 battalion company commanders, Capt. Silas S. Soule and Lt. Joseph A.  
34 Cramer, who ordered their companies to stand down and not fire, the  
35 entire village of 750 would have been annihilated. Soldiers then mutilated  
36 the dead, carrying "trophies" to Denver to display them at a theater  
37 production. The Sand Creek Massacre opened full-scale war on the  
38 western plains. Thirty-three chiefs were present at Sand Creek; of these

1 18 were killed:

21 The Sand Creek National Historic Site is located in Kiowa County  
22 near Eads, CO."; and

23 WHEREAS, The sculpture and the plaque would serve to  
24 memorialize the victims of the Sand Creek Massacre of November 29,  
25 1864; now, therefore,

26 *Be It Resolved by the Senate of the Seventy-first General Assembly*  
27 *of the State of Colorado, the House of Representatives concurring herein:*

28 That we, the members of the General Assembly, do hereby  
29 approve of the plan recommended by the State Capitol Building Advisory  
30 Committee, the Capital Development Committee, and the Governor for  
31 the installation of the sculpture and the accompanying explanatory plaque  
32 on the State Capitol grounds.

33 *Be It Further Resolved*, That copies of this Joint Resolution be  
34 transmitted to the Governor, the State Capitol Building Advisory  
35 Committee, the Capital Development Committee, the One Earth Future  
36 Foundation, and the Arsenault Family Foundation.
