19	Executive Secretary from its creation until 2015; and
20	WHEREAS, Jack Annan was a member of the Sterling Lions
21	Club, a life-long member of the Sterling Elks Lodge, a member of the
22	Sterling Masonic Lodge as a 32nd Degree Scottish Rite Mason, and a
23	member of the Sterling First Presbyterian Church where he served as an
