**AN ACT CONCERNING FUNDING FOR TOBACCO CONTROL,  
PREVENTION AND CESSATION PROGRAMS AND SERVICES.**

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 That the sum of twelve million dollars be appropriated to the
- 2 Department of Public Health, from the Tobacco Settlement Fund, for the

3 fiscal year ending June 30, 2023, and annually thereafter, for the purpose  
4 of providing tobacco control, prevention and cessation programs and  
5 services in accordance with the Centers for Disease Control and  
6 Prevention best practices, as amended from time to time.

***Statement of Purpose:***

To provide twelve million dollars annually for tobacco control, prevention and cessation efforts that are in accordance with the Centers for Disease Control and Prevention best practices.
