## AN ACT CONCERNING STUDIES OF THE EFFECT OF LEGALIZED GAMBLING.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

Section 1. Section 12-564 of the general statutes is repealed and the
 following is substituted in lieu thereof (*Effective from passage*):

3 (a) The commissioner shall make an annual report in writing to the 4 Governor as provided in section 4-60 and shall make such additional 5 reports as the Governor may from time to time reasonably request. The 6 annual report shall include a statement of the receipts and 7 disbursements of the department, a statement of the costs of 8 administering the department, a summary of *its* the department's 9 activities, and any additional information and recommendations which 10 the commissioner may deem of value or which the Governor may 11 request.

(b) (1) The commissioner shall conduct studies concerning the effect
of legalized gambling on the citizens of this state. [including] <u>The</u>
<u>studies shall include</u>, but <u>need</u> not <u>be</u> limited to, [studies to determine]
<u>examinations of</u> the types of gambling activity engaged in by the public,

16 the impact of the expansion of legalized gaming in neighboring states, 17 including the operation of additional casinos near the state, the potential 18 impact of online gaming in the state, the impact of the development of new gaming technologies and the desirability of expanding, 19 20 maintaining or reducing the amount of legalized gambling permitted in 21 this state. [Such studies shall be conducted as often as the commissioner 22 deems necessary, except that no studies shall be conducted before the 23 fiscal year ending June 30, 2009, and thereafter studies shall be conducted at least once every ten years. The] 24

25 (2) The commissioner shall conduct such studies not later than 26 October 1, 2021, and every ten years thereafter, and at such other times 27 as the commissioner deems necessary. The commissioner shall submit 28 the findings of such studies and the costs of conducting such studies to 29 the joint standing [committees] committee of the General Assembly 30 having cognizance of matters relating to [legalized gambling shall each 31 receive a report concerning each study carried out, stating the findings of the study and the costs of conducting the study] public safety and 32 33 security, in accordance with the provisions of section 11-4a.

This act shall take effect as follows and shall amend the following sections:
