AN ACT PROHIBITING ACCESS TO STATE PARKS AND FORESTS FOR CERTAIN CONDUCT.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- Section 1. Section 23-4 of the general statutes is repealed and the following is substituted in lieu thereof (*Effective October 1, 2022*):
- 3 (a) The Commissioner of Energy and Environmental Protection may 4 adopt regulations in accordance with the provisions of chapter 54 for 5 the maintenance of order, safety and sanitation upon the lands under 6 the commissioner's control and for the protection of trees and other 7 property and the preservation of the natural beauty thereof and fix 8 penalties not exceeding a fine of ninety dollars for violation of such 9 regulations. The commissioner may prohibit the possession or 10 consumption of alcoholic beverages on such lands provided, for any 11 such lands where the consumption or possession of alcoholic beverages 12 was not prohibited by the commissioner as of October 1, 1999, the 13 commissioner shall adopt regulations, in accordance with the 14 provisions of chapter 54, to prohibit such activity. Such regulations shall 15 be posted in conspicuous places upon such lands. Any person who

16 violates any such regulation shall have committed an infraction and 17 may pay the fine by mail or plead not guilty under the provisions of 18 section 51-164n. The provisions of section 51-164m shall not apply to this 19 section. Any person convicted of a violation of such regulations or who 20 forfeits a bond taken upon any such complaint may be prohibited from 21 entering any state park by the commissioner for not more than one year 22 from the date of such conviction. Any person who: (1) Threatens or commits an act of violence against any person in any state park or forest, 23 24 or (2) vandalizes any property in any state park or forest may be 25 prohibited from entering any state park or forest by the commissioner 26 for not more than one year from the date of such act.

(b) Notwithstanding the provisions of subsection (a) of this section and any regulation adopted pursuant to said subsection, the commissioner shall authorize any person to take mushrooms from any lands under the control of the commissioner provided such taking is for personal use only. The state shall have no liability to any person or the heirs or assigns of any such person who engages in the taking of mushrooms from any lands under the control of the commissioner.
