AN ACT AUTHORIZING THE DEFERRAL OF A PROPERTY REVALUATION.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (*Effective from passage*) (a) Notwithstanding the provisions 2 of section 12-62 of the general statutes or any municipal charter, special act or home rule ordinance, the municipalities of Wethersfield, 4 Middletown and Stamford, which are required to implement a 5 revaluation of real property for the assessment year commencing 6 October 1, 2023 pursuant to section 12-62 of the general statutes, may 7 defer such implementation until the assessment year commencing 8 October 1, 2024, provided such deferral is approved by the legislative 9 body of such municipality. The rate maker, as defined in section 12-131 10 of the general statutes, in any municipality that defers the 11 implementation of a revaluation pursuant to this subsection may
- 14 (b) Any required revaluation subsequent to any deferred 15 revaluation implemented pursuant to subsection (a) of this section 16 shall be implemented in accordance with the provisions of section 12-17 62 of the general statutes. Such subsequent revaluation shall 18 recommence at the point in the schedule required pursuant to section 19 12-62 of the general statutes that the municipality was following prior
