RESOLUTION CONCERNING THE RULES OF THE HOUSE OF REPRESENTATIVES FOR THE JULY SPECIAL SESSION, 2021.

Resolved by this House:

- 1 That the rules of the House at this Special Session shall be the same
- 2 as the rules of the House in force at the 2021 regular session, except as
- 3 said rules are amended, altered or repealed in this resolution.
- 4 Strike out Rule 9.
- 5 Strike out Rule 11 and insert in lieu thereof the following:
- 6 11. (a) Each bill or substantive resolution may be acted upon in the
- 7 House immediately after electronic notice of the filing and number of
- 8 the bill or substantive resolution is provided to the members of the
- 9 House, and after final action may be transmitted immediately to the
- 10 Senate. If the House rejects an amendment adopted by the Senate, the
- 11 bill or substantive resolution after final action in the House may be
- 12 transmitted immediately to the Senate. If the Senate rejects an
- amendment adopted by the House, the bill or substantive resolution

- 14 when received from the Senate may be acted upon immediately.
- 15 (b) A bill or resolution certified in accordance with section 2-26 of the
- 16 general statutes, if filed in the House, may be transmitted to and acted
- 17 upon first by the Senate with the consent of the speaker; and if filed in
- 18 the Senate, may be transmitted to and acted upon first by the House
- 19 with the consent of the President Pro Tempore.
- 20 Strike out Rules 15, 19 and 20.
- 21 Strike out Rule 21 and insert in lieu thereof the following:
- 22 21. The order of business shall be as follows:
- 23 1. Reception of communications from the Governor and the Secretary
- 24 of the State.
- 25 2. Introduction of bills and resolutions.
- 26 3. Reception of business from the Senate.
- 4. Miscellaneous.
- 28 Strike out Rules 32 and 33.
- 29 Add a new Rule 51 as follows:
- 30 51. Only those bills and substantive resolutions specified in Rule 7 of
- 31 the Joint Rules for this session, certified as provided in Rule 9 of said
- 32 Joint Rules, and, except as provided in Rule 33 of said Joint Rules, only
- 33 those resolutions pertaining to the rules of this Special Session, the
- 34 printing of the journals of the Senate and the House of Representatives,
- and the expenses of this Special Session, shall be received.
