## AN ACT CONCERNING BODY ARMOR FOR FIREFIGHTERS AND EMERGENCY MEDICAL SERVICES PERSONNEL.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

Section 1. Subsection (b) of section 53-341b of the general statutes is
repealed and the following is substituted in lieu thereof (*Effective October*

3 1, 2020):

4 (b) The provisions of subsection (a) of this section shall not apply to 5 the sale or delivery of body armor to (1) a sworn member or authorized 6 official of an organized local police department, the Division of State 7 Police within the Department of Emergency Services and Public 8 Protection, the Division of Criminal Justice, the Department of 9 Correction, the Board of Pardons and Paroles or the Department of 10 Motor Vehicles, (2) an authorized official of a municipality or the 11 Department of Administrative Services that purchases body armor on 12 behalf of an organized local police department, the Division of State 13 Police within the Department of Emergency Services and Public 14 Protection, the Division of Criminal Justice, the Department of 15 Correction, the Board of Pardons and Paroles or the Department of

16 Motor Vehicles, (3) an authorized official of the Judicial Branch who 17 purchases body armor on behalf of a probation officer or a judicial 18 marshal, [or] (4) a member of the National Guard or the armed forces 19 reserve, (5) a firefighter or an authorized official of a municipal fire 20 department or volunteer fire company, or (6) emergency medical services personnel, as defined in section 20-206jj, or an authorized 21 22 official of an emergency medical service organization licensed or 23 certified pursuant to chapter 368d.

24 Sec. 2. (NEW) (Effective October 1, 2020) Each municipal fire 25 department, volunteer fire company and emergency medical service 26 organization licensed or certified pursuant to chapter 368d of the 27 general statutes, shall ensure that each vehicle operated by such 28 department, company or organization is equipped with body armor, as 29 defined in section 53a-217d of the general statutes, sufficient for the 30 number of persons reasonably anticipated to occupy such vehicle at any 31 one time.

This act shall take effect as follows and shall amend the following sections:

## Statement of Purpose:

To (1) allow firefighters, fire departments, emergency services personnel and emergency medical service organizations to purchase or receive body armor without meeting the transferor of such body armor in person, and (2) require fire departments and emergency medical service organizations to equip their vehicles with body armor.
