## Raised Bill No. 279

## AN ACT CONCERNING CERTIFICATION FOR REMOVABLE WINDSHIELD PLACARDS FOR PERSONS WHO ARE BLIND AND PERSONS WITH DISABILITIES AND THE MEMBERSHIP OF THE ACCESSIBLE PARKING ADVISORY COUNCIL.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

Section 1. Subsection (b) of section 14-253a of the 2024 supplement to
 the general statutes is repealed and the following is substituted in lieu
 thereof (*Effective October 1, 2024*):

4 (b) The Commissioner of Motor Vehicles shall accept applications 5 and renewal applications for removable windshield placards from (1) 6 any person who is blind, as defined in section 1-1f; (2) any person with 7 disabilities; (3) any parent or guardian of any person who is blind or any 8 person with disabilities, if such person is under eighteen years of age at 9 the time of application; (4) any parent or guardian of any person who is 10 blind or any person with disabilities, if such person is unable to request 11 or complete an application; and (5) any organization which meets 12 criteria established by the commissioner and which certifies to the 13 commissioner's satisfaction that the vehicle for which a placard is 14 requested is primarily used to transport persons who are blind or

15 persons with disabilities. Except as provided in subsection (c) of this 16 section, on and after October 1, 2011, the commissioner shall not accept 17 applications for special license plates, but shall accept renewal 18 applications for such plates that were issued prior to October 1, 2011. 19 No person shall be issued a placard in accordance with this section 20 unless such person is the holder of a valid motor vehicle operator's 21 license, or identification card issued in accordance with the provisions 22 of section 1-1h. The commissioner [is authorized to] may adopt 23 regulations, in accordance with the provisions of chapter 54, for the 24 issuance of placards to persons who, by reason of hardship, do not hold 25 or cannot obtain an operator's license or identification card. The 26 commissioner shall maintain a record of each placard issued to any such 27 person. Such applications and renewal applications shall be on a form 28 prescribed by the commissioner. The application and renewal 29 application shall include: (A) Certification by [a licensed physician, a] (i) 30 the applicant's treating physician, licensed pursuant to chapter 370, 31 physician assistant, [an] licensed pursuant to chapter 370 or advanced 32 practice registered nurse, licensed [in accordance with the provisions of 33 chapter 378, or] pursuant to chapter 378, (ii) a person who holds a 34 similar license and is participating in the same group practice, as 35 defined in section 19a-486i, as such treating physician, physician 36 assistant or advanced practice registered nurse, or (iii) a member of the 37 driver training unit for persons with disabilities established pursuant to 38 section 14-11b, that the applicant meets the definition of a person with a 39 disability which limits or impairs the ability to walk, as defined in 23 40 CFR Section 1235.2; or (B) certification by a psychiatrist who is 41 employed by, or under contract with, the United States Department of 42 Veterans Affairs that the applicant (i) is a veteran, as defined in 43 subsection (a) of section 27-103, who has post-traumatic stress disorder 44 certified as service-connected by the United States Department of 45 Veterans Affairs, and (ii) meets the definition of a person with a 46 disability which limits or impairs the ability to walk, as defined in 23 47 CFR Section 1235.2. In the case of persons who are blind, the application 48 or renewal application shall include certification of legal blindness 49 made by the Department of Aging and Disability Services, an

50 ophthalmologist or an optometrist. Any person who makes a 51 certification required by this subsection shall sign the application or 52 renewal application under penalty of false statement pursuant to section 53 53a-157b. The commissioner, in said commissioner's discretion, may 54 accept the discharge papers of a disabled veteran, as defined in section 55 14-254, in lieu of such certification. The Commissioner of Motor Vehicles 56 may require additional certification at the time of the original 57 application or at any time thereafter. If a person who has been requested 58 to submit additional certification fails to do so within thirty days of the 59 request, or if such additional certification is deemed by the 60 Commissioner of Motor Vehicles to be unfavorable to the applicant, the 61 commissioner may refuse to issue or, if already issued, suspend or 62 revoke such special license plate or placard. The commissioner shall not 63 issue more than one placard per applicant, except the commissioner 64 shall issue one placard to each applicant who is a parent or guardian of 65 any person who is blind or any person with disabilities, provided no more than two such placards shall be issued on behalf of such person. 66 67 The fee for the issuance of a temporary removable windshield placard 68 shall be five dollars. Any person whose application has been denied or 69 whose special license plate or placard has been suspended or revoked 70 shall be afforded an opportunity for a hearing in accordance with the 71 provisions of chapter 54.

Sec. 2. Subsection (b) of section 14-253c of the 2024 supplement to the
general statutes is repealed and the following is substituted in lieu
thereof (*Effective from passage*):

75 (b) The advisory council shall consist of (1) the Commissioner of 76 Motor Vehicles or the commissioner's designee, (2) the Commissioner of 77 Aging and Disability Services or the commissioner's designee, (3) two 78 members appointed by the Commissioner of Motor Vehicles, who are 79 licensed physicians, physician assistants or advanced practice registered 80 nurses who certify applications for removable windshield placards 81 while in the course of employment, (4) one member appointed by the 82 Commissioner of Aging and Disability Services who represents an 83 organization that advocates on behalf of persons with physical

disabilities, (5) one appointed by the House chairperson of the joint 84 85 standing committee of the General Assembly having cognizance of 86 matters relating to transportation, [who is a municipality planner,] (6) 87 one appointed by the Senate chairperson of the joint standing committee 88 of the General Assembly having cognizance of matters relating to 89 transportation, who uses accessible parking or advocates on behalf of 90 such users, [of accessible parking,] (7) one appointed by the House 91 ranking member of the joint standing committee of the General 92 Assembly having cognizance of matters relating to transportation, who 93 uses accessible parking or advocates on behalf of such users, [of 94 accessible parking,] (8) one appointed by the Senate ranking member of 95 the joint standing committee of the General Assembly having 96 cognizance of matters relating to transportation, who is a sworn 97 member of a municipal police department, and (9) and such other 98 members as the advisory council may prescribe. All initial 99 appointments to the advisory council shall be made not later than 100 September 1, 2023. Each member appointed pursuant to subdivisions (3) 101 to (9), inclusive, of this subsection shall serve for a term of two years and 102 may serve until such member's successor is appointed. Any vacancy 103 shall be filled by the appointing authority. The Commissioner of Motor 104 Vehicles, or the commissioner's designee, shall serve as chairperson of 105 the advisory council. The advisory council shall meet at such times as it 106 deems necessary and may establish rules governing its internal 107 procedures.

To (1) permit a licensed professional in the same group practice as the applicant's treating physician, physician assistant, advanced practice registered nurse to certify that the applicant meets the definition of a person with a disability which limits or impairs the ability to walk, and (2) amend the membership of the Accessible Parking Advisory Council.
