## AN ACT ESTABLISHING THE LEARN, WORK, PAY PROGRAM.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. (NEW) (*Effective July 1, 2021*) (a) As used in this section:

(1) "Eligible graduate" means a person who (A) graduates on or after
January 1, 2022, with a bachelor's degree from a public institution of
higher education in the state, (B) is a resident of the state, (C) is
employed by any corporation or organization licensed to operate a
business in the state, and (D) has a student loan on which such person
has paid or will pay not less than the first twelve monthly payments;

8 (2) "Student loan" means any loan in repayment status that was 9 issued by a private or governmental lender to finance attendance at a 10 public institution of higher education in the state; and

(3) "Participation year" means a twelve-month period commencing
from the thirteenth month in which a student loan payment is due or
the first full calendar month after an application to participate in the
Learn, Work, Pay Program is approved, whichever is later, and each

succeeding twelve-month period thereafter, for ten years or untilwithdrawal from the program.

17 (b) Not later than January 1, 2022, the Comptroller shall establish a 18 Learn, Work, Pay Program for the purpose of providing student loan 19 reimbursements to eligible graduates. The Comptroller may (1) adopt 20 rules, procedures and forms necessary to implement such program, or 21 (2) enter into a contract with a third-party administrator to provide 22 administrative services for the program. Any such third-party 23 administrator shall be required under such contract to charge such 24 third-party administrator's lowest available rate for such services.

25 (c) On or after January 1, 2022, an eligible graduate may apply, in the 26 form and manner prescribed by the Comptroller, to participate in the 27 Learn, Work, Pay Program. An eligible graduate shall submit, with an 28 initial application, proof of (1) graduation with a bachelor's degree from 29 a public institution of higher education in the state, (2) residency and 30 employment in the state, and (3) the repayment status of a student loan. 31 For each participation year, an eligible graduate shall (A) submit 32 documentation of the amount paid and the amount due on a student 33 loan during the preceding twelve-month period, (B) submit proof of 34 continued eligibility under the program, and (C) receive a student loan 35 reimbursement from the Comptroller in accordance with the payment 36 schedule provided in subsection (d) of this section, provided such 37 eligible graduate continues to meet the eligibility requirements of this 38 section.

39 (d) An eligible graduate who participates in the Learn, Work, Pay 40 Program shall receive annual student loan reimbursements in an 41 amount not to exceed ten per cent of the amount paid on a student loan 42 during the preceding twelve-month period for the first participation 43 year, twenty per cent of such amount for the second participation year, 44 thirty per cent of such amount for the third participation year, forty per 45 cent of such amount for the fourth participation year, fifty per cent of 46 such amount for the fifth participation year, sixty per cent of such 47 amount for the sixth participation year, seventy per cent of such amount

48 for the seventh participation year, eighty per cent of such amount for 49 the eighth participation year, ninety per cent of such amount for the 50 ninth participation year and one hundred per cent of such amount for 51 the tenth participation year. For any participation year in which a 52 program participant ceases to reside or work in the state or no longer 53 owes student loan payments, such participant shall be deemed to have 54 withdrawn from the program and be ineligible to receive any 55 subsequent student loan reimbursements.

- (e) There is established an account to be known as the "Learn, Work,
  Pay account" which shall be a separate, nonlapsing account within the
  General Fund. The account shall contain any moneys required by law to
  be deposited in the account. Moneys in the account shall be expended
  by the Comptroller for the purposes of the Learn, Work, Pay Program.
