AN ACT ALLOWING CERTAIN SUPPLEMENTAL NUTRITION ASSISTANCE BENEFICIARIES TO USE ELECTRONIC BENEFIT TRANSFER CARDS AT PARTICIPATING RESTAURANTS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (NEW) (*Effective from passage*) (a) As used in this section: (1)
- 2 "Restaurant Meals Program" means a federal program that allows
- 3 eligible beneficiaries of supplemental nutrition assistance to purchase
- 4 meals at participating restaurants using their electronic benefit transfer
- 5 cards, (2) "eligible beneficiaries" means an elderly or disabled member,
- 6 as defined in 7 USC 2012(j), and the spouse of such member, and
- 7 homeless individuals, as defined in 7 USC 2012(1), and (3) "electronic
- 8 benefit transfer card" means a card allowing for the transfer of payments
- 9 from state administered programs, including, but not limited to,
- 10 supplemental nutrition assistance.
- 11 (b) Not later than July 1, 2021, the Commissioner of Social Services
- shall develop and implement a plan to commence participation in the
- 13 Restaurant Meals Program beginning not later than October 1, 2021. The
- 14 plan shall identify restaurants that contract with the Department of

- 15 Social Services to offer meals to eligible beneficiaries at concessional
- prices pursuant to 7 USC 2018(h) and allow eligible beneficiaries to use
- 17 their electronic benefit transfer cards to purchase such meals.
- 18 (c) The Department of Social Services shall adopt policies and 19 procedures to implement the provisions of this section. The department may implement such policies and procedures while in the process of 20 21 adopting such policies and procedures in regulation form, provided the 22 department posts notice of intent to adopt regulations on the 23 eRegulations System and the department's Internet web site not later 24 than twenty days after adopting such policies and procedures. Such 25 policies shall be valid until the time final regulations are adopted.
