28	For the purposes of this act, the term:
29	(1) "Chancellor" means the Chancellor of the District of Columbia Public Schools as
30	provided for in section 38-174 of the D.C. Official Code.
31	(2) "DCPS" means the District of Columbia Public Schools as established in section 38-
32	171of the D.C. Official Code.
33	Sec. 3. Establishment of the Thurgood Marshall Early Education Learning Academy Pilot
34	Program.
35	(a) The State Superintendent of Education shall establish and administer the
36	Thurgood Marshall Early Education Learning Academy Pilot Program ("Pilot Program") located
37	at 3100 Fort Lincoln Dr. NE beginning in the 2013-2014 school year. The Pilot Program shall

1	incorporate the "Reading Development and Grade 3 Retention Act of 2013," as introduced on
2	January 08, 2013 (D.C. Bill 20-41) and the Early Childhood Education Act of 2012, effective
3	June 19, 2012 (D.C. Law 19-142; D.C. Official Code § 38-751.01). The Pilot Program shall:
4	(1) Enroll 350 children between the ages of three (3) and five (5) who
5	qualify for the free and reduced lunch program, as follows:
6	(A) 150 three (3) year olds;
7	(B) 100 four (4) year olds; and
8	(C) 100 five (5) year olds;
9	(2) Provide an all-day, comprehensive, and research based curriculum,
0	in accordance with the requirements set out in the Early Childhood Education Act of 2012,

2	enrolled students for entry to and achievement in kindergarten, first, and all subsequent grades;
