Dear Chairman Mendelson:

Enclosed for the consideration of the Council of the District of Columbia is legislation entitled "Closing of a Portion of the Public Alley and Acceptance of Dedication of Land for Alley Purposes in Square 75, S.O. 12-03806, Act of 2013". This bill proposes the closing of a public alley bounded by Pennsylvania Avenue, 21st Street, I Street, and 22nd Street in Northwest Washington, D.C., in Ward 2. The bill also proposes that the Council accept the dedication of land for alley purposes at the same location.

The Applicant is the George Washington University. The Applicant is represented by the law firm Goulston & Storrs. The purpose of the closing is to facilitate the consolidation of the Applicant's property and provide for the development of an 11-story office building.

Pursuant to D.C. Official Code § 9-202.02, the application was referred to Advisory Neighborhood Commission 2A on August 30, 2012. In a letter to the Surveyor dated October 8, 2013, the ANC Chair indicated that the ANC at its regularly scheduled public meeting held on September 18, 2013, at which a quorum was present, voted to support the alley reconfiguration, but requested a "fully noticed hearing" on the application.

This closing will have no effect on the operating or capital budget for the current or next five fiscal years.

The portion of the alley to be closed in Square 75 is improved and was created by original subdivision of the square, recorded in Record Book 1, Page 75 on July 16, 1795. Title to the alley could not be determined to be held with the District of Columbia or the Federal Government.

Enclosed is a copy of the plat for recording this closing and dedication along with a copy of the application file and draft legislation.

18	Sec. 2. Pursuant to Section 201 of the Street and Alley Closing and Acquisition

21	§ 9-202.01), the Council finds that the portion of the public alley in Square 75, as shown

## Conclusion

Funds are sufficient in the FY 2014 through FY 2017 budget and financial plan to implement the bill.

## Background

The bill orders a portion of the public alley in Square 75<sup>1</sup> closed and dedicates a separate portion of the Square to the public alley system. George Washington University (GWU) is the sole property owner of all the property in Square 75 and intends to redevelop the property as a new eleven-story commercial office building. The plan includes improving circulation at the rear of the new development by closing a portion of the alley and widening other parts of the alley.

#### **Financial Plan Impact**

Funds are sufficient in the FY 2014 through FY 2017 budget and financial plan to implement the bill.

The District Department of Transportation (DDOT) does not object to the modifications and indicates the changes will not adversely impact transportation. However, there is one existing DDOT alley light that will need to be relocated at the expense of GWU. The estimated cost of relocating the light is \$6,975, and will be covered by GWU.
