

A BILL

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To establish the Made in DC Program within the Department of Small and Local Business Development to promote the locally created, manufactured, or assembled products in the program; to establish the Made in DC Fund to further support the program; and to require the Department of Small and Local Business Development to report on opportunities for a District-sponsored Innovation Studio Space and Marketplace.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Made in DC Program Establishment Act of 2015".

Sec. 2. Made in DC Program.

(a) There is established, within the Department of Small and Local Business Development ("Department"), a Made in DC Program ("Program").

(b) The Department shall:

(1) Develop the Made in DC Brand ("Brand") as an identifier of District-created products;

(2) Raise awareness of locally crafted products;

(3) Promote the purchase of locally crafted products;

- 41 (5) Develop a logo that represents the Brand;
- 42 (6) Provide support to help businesses utilize the Brand;
- 43 (7) Produce public service announcements, marketing materials, stickers,
44 flyers, and digital logos reflecting the Brand;
- 45 (8) Conduct a public awareness campaign to promote the Brand;
- 46 (9) Coordinate with the Department of Consumer and Regulatory Affairs to
47 market the Program to local businesses who produce eligible goods;
- 48 (10) Coordinate with Events DC and Destination DC to market the Brand
49 and Made in DC products to conventions, tourists, and major events;
- 50 (11) Maintain, on the Department website, a list of every Made in DC product
51 with the contact information for the business, including telephone number, website, and
52 social media links; and
- 53 (12) Monitor the use of the Brand in order to identify and stop the
54 unauthorized use of the Brand and its associated logo.

55 (c)(1) Upon application, the Department shall approve a product's use of the Brand
56 provided the individual or business creating the product:

- 57 (A) Is located in the District; and
- 58 (B) Produces, manufactures, or assembles the product in the District.

59 (2)(A) Following initial approval, the Department shall review each approved
60 product every 3 years to confirm its continued eligibility.

61 (B) If the product no longer meets eligibility requirements, the
62 Department shall revoke its approval of the use of the Brand.

63 Sec. 3. Made in DC Fund.

64 (a) There is established as a special fund the Made in DC Fund ("Fund"), which shall
65 be administered by the Department of Small and Local Business Development in
66 accordance with section 2 of this act.

67 (b) Revenue from the following sources shall be deposited in the Fund:

68 (1) Funds appropriated by the District of Columbia;

69 (2) Donations from the public; and

70 (3) Donations or grants from private entities.

71 (c) Money in the Fund shall be used to promote the Made in DC Program as set
72 forth in section 2 of this act.

73 Sec. 4. Innovation Studio Space and Marketplace Report.

74 (a) Within 180 days of the effective date of this act, the Department of Small and
75 Local Business Development shall submit to Council a report on opportunities for a
76 District-sponsored Innovation Studio Space and Marketplace that would support the local
77 arts, craft, and maker community by providing low-cost membership for access to studio
78 space, high-end equipment, sales gallery space, and classrooms.

79 (b) The report shall:

80 (1) Assess the availability of District property for use as an Innovative
81 Studio Space and Marketplace;

82 (2) Estimate the cost of developing potential sites for such use;

83 (3) Estimate the costs of operating and maintaining the site;

84 (4) Explore the availability of private donations or grants to support the
85 studio space and purchase a wide range of equipment, including tools for 3D printing and
86 prototyping, woodworking, metal working, welding, sewing, screen printing, electronics,
87 and robotics; and

88 (5) Consider the most efficient management option for the Innovative Studio
89 Space and Marketplace.

90 (c) To prepare the report, the Department shall work with a variety of stakeholders,
91 including:

92 (1) Members of the art, craft, and maker communities;

93 (2) Local creative organizations;

94 (3) Universities and colleges;

95 (4) The Commission on Arts and Humanities; and

96 (5) The Deputy Mayor for Planning and Economic Development.

97 Sec. 5. Fiscal impact statement.

98 The Council adopts the fiscal impact statement in the committee report as the fiscal
99 impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act,
100 approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(3)).

101 Sec. 6. Effective date.

102 This act shall take effect following approval by the Mayor (or in the event of veto by
103 the Mayor, action by the Council to override the veto), a 30-day period of congressional
104 review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved
105 December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the
106 District of Columbia Register.
