hairman Phil Mendelson at the request of the Mayor A BILL IN THE COUNCIL OF THE DISTRICT OF COLUMBIA Chairman Phil Mendelson, at the request of the Mayor, introduced the following bill. which was referred to the Committee on _____. To amend the Department of Motor Vehicles Establishment Act of 1998 to allow the Director of the Department of Motor Vehicles to extend due dates for matters under the jurisdiction of the Department. BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA. That this act may be cited as the "Department of Motor Vehicles Extension of Deadlines Amendment Act of 2016". Sec. 2. Section 1822 of the Department of Motor Vehicles Establishment Act of 1998, effective March 26, 1999 (D.C. Law 12-175; D.C. Official Code § 50-901), is amended by adding a new paragraph (c) to read as follows: "(c) Notwithstanding any other law, the Director of the DMV may extend the time period for a person to adjudicate or pay a notice of infraction, renew registration of a vehicle, pass a vehicle inspection, renew a noncommercial or commercial driver license. provisional permit, or commercial learner permit without penalty to account for the closure of the District government or the DMV due to an emergency, an administrative

Conclusion

Funds are sufficient in the fiscal year 2016 budget and the proposed fiscal year 2017 through fiscal year 2020 budget and financial plan to implement the bill.

Background

The bill gives the Director of the Department of Motor Vehicles (DMV) the authority to delay deadlines for its services, without penalty, if the District of Columbia Government or DMV is closed due to an emergency or administrative closure. These delays apply to the timelines for infraction adjudications, vehicle inspections, driver's license or permit renewals, and vehicle registration renewals.

Financial Plan Impact

Funds are sufficient in the fiscal year 2016 budget and the proposed fiscal year 2017 through fiscal year 2020 budget and financial plan to implement the bill. Individuals will avoid late fees and penalties that are associated with missing a deadline with this extension authority. There is no impact on the District's budget and financial plan.
